INDIVIDUAL NAMING HIMSELF CLINT NICKERSON, TORONTO, CANADA,
TELEPHONICALLY CONTACTED ASAC FRANCIS X. O'NEIL, JR., STATING HE
WAS DOING RESEARCH ON KENNEDY ASSASSINATION AND SINCE ASAC O'NEILL
HAD BEEN PRESENT DURING KENNEDY AUTOPSY AT BETHESDA, MD., WANTED TO
KNOW IF HE AGREED WITH AUTOPSY FINDINGS AS PROMULGATED BY THE WARREN
COMMISSION REPORT. FURTHER, HE WANTED TO KNOW WHEREABOUTS OF
JAMES SIBERT WHO WAS PRESENT WITH ASAC O'NEILL 11/22/63 AT BETHESDA.
IN ADDITION, STATED IN VIEW OF RECENT PUBLICITY AFFORDED KENNEDY
ASSASSINATION, WANTED TO KNOW IF O'NEILL WOULD BE FREE TO DISCUSS
HIS PARTICIPATION IN INVESTIGATION. HE WAS ADVISED ASAC WOULD HAVE
NO COMMENTS TO MAKE CONCERNING THE ASSASSINATION AND ANY INQUIRIES
SHOULD BE DIRECTED TO FBI HQTRS, WASHINGTON, D.C., ATTN ASSISTANT
DIRECTOR, EXTERNAL AFFAIRS DIVISION.
