Bureau files contain no records identifiable with [redacted] or [redacted] based on information furnished. Bureau files contain a LFIS case in which [redacted] is a subject. Office of origin is Tampa and Jacksonville's file number is 15-2942.

From the description of the documents furnished by [redacted] it would appear that the items in question could be material relating to the Warren Commission investigation of the assassination which is available to the public through the Archives of the United States.

Jacksonville, interview [redacted] to determine her knowledge of this matter and obtain any documents she may have in her possession. Furnish Bureau any additional information obtained regarding Brown.

Re: ASSASSINATION OF PRESIDENT JOHN F. KENNEDY

NOTE: [REDACTED], who is in jail in Palatka, Florida, on stolen property charge, was interviewed at his request by FBI Agent on 9/10/75. He told of delivering a file drawer of documents to Atlanta, Georgia, for a [REDACTED] of Daytona Beach, Florida, approximately two years ago. File drawer contained documents concerning assassination of President Kennedy. [REDACTED] was under impression documents were stolen and [REDACTED] told him he intended to sell them to an unidentified attorney in Atlanta. Berner said his wife, [REDACTED], and his "girl friend," [REDACTED] saw the documents and [REDACTED] took one or more as souvenirs. Jacksonville is already making discreet inquiries to identify Brown. Bureau files contain no information identifiable with [REDACTED] or [REDACTED] based on information furnished. Bureau files contain 1973 TFIS case in which [REDACTED] was the subject in a theft of household goods matter.
