TRAILER AND WAS IN TRUCKING BUSINESS. [REDACTED] SAID HE EXAMINED CONTENTS OF FILE DRAWER AND THEY CONTAINED DOCUMENTS CONCERNING ASSASSINATION OF JOHN F. KENNEDY, INCLUDING PHOTOS OF RUBY, OSWALD, KENNEDY, REPORT OF BALLISTIC TESTS, TELEGRAMS SENT BY RUBY AND OSWALD, AND NUMEROUS OTHER DOCUMENTS. HE SAID HE WAS UNDER IMPRESSION DOCUMENTS MAY HAVE BEEN STOLEN AND [REDACTED] TOLD HIM HE INTENDED TO SELL THEM TO AN UNIDENTIFIED ATTORNEY IN ATLANTA. [REDACTED] DELIVERED DOCUMENTS TO ATLANTA FROM DAYTONA, WHERE HE WAS MET BY [REDACTED] AT EIGHT-DAYS INN NEAR THE FARMER'S MARKET, AND HE TRANSFERRED FILE DRAWER FROM TRUCK TO VEHICLE WHICH HE COULD NOT IDENTIFY DRIVEN BY [REDACTED] STATED HE BELIEVED [REDACTED] FLEW FROM DAYTONA TO ATLANTA TO MEET HIM.
