which have been identified as former clerk THOMAS J.
BEVANS who is currently a Special Agent assigned to
Los Angeles Division. This teletype was blockstamped
November 22, 1963, and initialed by former SAC HARRY G.
MAYNOR.

The second teletype which was sent by the
Bureau at 9:42 PM and received at New Orleans at 8:44PM CST
also by THOMAS J. BEVANS currently a Special Agent assigned
to the Los Angeles Division was blockstamped November 22,
1963 and is initialed by former New Orleans Supervisor

JOHN REYNOLDS. It is noted that the first teletype was not clear and the second teletype appears to be merely a clarification of the first teletype.

The Bureau additionally requested New Orleans to determine if ROY SIMON was previously employed in a clerical capacity by this division and it has been determined that ROY JOSEPH SIMON, JR., was employed at the New Orleans Division sometime subsequent to 1961, although all files pertaining to his employment at New Orleans have been sent to the Bureau following his departure from Bureau service.

It is further noted that on teletype sent from the Bureau 11/22/63, at 9:42 PM, received at New Orleans 8:44 PM CST the following was written in pencil on this communication, "8:30 AM 11/23/63 Jennings Yazoo, Mis."

The pencil notation referred to telephone call to SA SAMUEL N. JENNINGS to ask him to contact his Klan and racial sources in Yazoo City, Mississippi area.
