REVIEW OF NEW YORK, 89-75, THE MAIN ASSASSINATION FILE
OF PRESIDENT KENNEDY WAS NEGATIVE CONCERNING ALLEGED TELETYPE
FROM FBIHQ TO SACS ON NOVEMBER 17, 1963 CAPTIONED, "THREAT
TO ASSASSINATE PRESIDENT KENNEDY IN DALLAS." THE 89-75 FILE
WHICH WAS OPENED AFTER ASSASSINATION CONTAINED GREEN CHARGEOUT
FOR EXISTING 66, 67 NOT IN FILE AT TIME FILE VOLUMES
CONSOLIDATED. NO INDICATION WHETHER THIS WAS DUE TO
MISSEPARLIZATION SERIALS 65, DATED NOVEMBER 24, 1963 AND
SERIAL 66, DATED NOVEMBER 24, 1963. CASE ASSIGNED TO SA

EUGENE O'NEILL, NOW RETIRED FROM BUREAU AND CURRENTLY PUBLIC
SAFETY DIRECTOR, BAYONNE, NEW JERSEY.

AIRTEL WAS LHM AND FULL DETAILS.
