CONTACTED THIS OFFICE TO ADVISE THAT HE WAS HIMSELF  
TELEPHONICALLY CONTACTED EARLIER THIS DATE BY AN UNKNOWN  
REPORTER AND QUESTIONED IN REFERENCE TO A POSSIBLE NOTE  
RECEIVED BY THE BUREAU PRIOR TO THE DEATH OF PRESIDENT  
KENNEDY WARNING OF HIS IMPENDING DEATH. BERGER ADVISED  
THAT HE WOULD LIKE SOMEONE TO CONTACT HIM BEFORE GIVING  
ANY ANSWERS TO THE PRESS. HE CAN BE CONTACTED AT

DIVISION TELEPHONICALLY CONTACTED THIS OFFICE AND ADVISED THAT SHE HAD JUST RECEIVED A LONG DISTANCE TELEPHONE CALL FROM AN INDIVIDUAL IDENTIFYING HIMSELF AS BEING A REPRESENTATIVE OF CBS NEWS WHO INFORMED HER THAT DAN RATHER WAS PRODUCING A SHOW REGARDING CAPTIONED MATTER FOR THE COMING SEASON. SHE WAS ADVISED BY THE CALLER THAT "THEY" HAD A LIST OF CLERKS THEY WERE CALLING FOR INFORMATION AND QUESTIONED HER THOROUGHLY INCLUDING ASKING WHETHER SHE HAD BEEN AWARE OF A TELETYPE COMING TO THE NEW ORLEANS DIVISION ALERTING NEW ORLEANS TO THE ASSASSINATION OF PRESIDENT KENNEDY. SHE GAVE NO AFFIRMATIVE ANSWERS TO ANY OF THE QUESTIONS ASKED OF HER. MRS. HEBBLER DID NOT KNOW HOW CBS NEWS GOT HER NAME OR TELEPHONE NUMBER AS SHE MARRIED SOMETIME AFTER LEAVING THE BUREAU.
