ON SEPT 29, 1975, FORMER SA REGIS KENNEDY TELEPHONICALLY CONTACTED  
 THE NEW ORLEANS DIVISION AND ADVISED HE HAD RECEIVED A TELEPHONE  
 CALL THAT DATE FROM A MR. PHILLIPS FROM CBS NEWS, NEW YORK. HE  
 WANTED TO INTERVIEW KENNEDY ON TELEVISION REGARDING TELETYPE  
 CONCERNING THE ASSASSINATION OF "PRESIDENT KENNEDY WHICH ALLEGEDLY  
 HAD BEEN RECEIVED PRIOR TO KENNEDY'S ASSASSINATION". ALERTING  
 FBI OFFICES TO THE POSSIBLE ATTEMPT TO ASSASSINATE KENNEDY.  
 ACCORDING TO KENNEDY, PHILLIPS INFORMED HIM THAT BILLY WALTER  
 HAS A COPY OF THE TELETYPE. FORMER SA KENNEDY INFORMED PHILLIPS  
 THAT HE KNEW NOTHING ABOUT WALTER, SUCH TELETYPE AND WOULD NOT CONTACT

TO AN INTERVIEW.

ON SEPT 29, 1975, BETTY N. KENDRICK, WHO WAS FORMERLY EMPLOYED AS A SECRETARY IN THE NEW ORLEANS DIVISION, TELEPHONICALLY ADVISED THAT HER HUSBAND, YEN KENDRICK, ALSO A FORMER CLERICAL EMPLOYEE, HAD RECEIVED AN INQUIRY FROM A DALLAS REPORTER IN REFERENCE TO A TELETYPE BILL WALTER SAID WAS RECEIVED BY THE NEW ORLEANS OFFICE PRIOR TO THE ASSASSINATION OF PRESIDENT KENNEDY. MRS. KENDRICK FURTHER STATED THAT THE REPORTER HAD INDICATED THAT HE HAD CONTACTED FORMER EMPLOYEES, TOM MC CUTLEY AND ROY E. SIMON, RELATIVE TO THE SAME MATTER. MRS. KENDRICK BELIEVED THAT THE REPORTER WAS EMPLOYED AT THE DALLAS TRIBUNE. MRS. KENDRICK CAN BE CONTACTED AT 504-880-9437.

ADDITIONAL REVIEWS OF THE NEW ORLEANS FILES 69-7 AND 89-69 FAIL TO LOCATE ANY TELETYPE CONTAINING THE NOTATIONS IN THE <sup>5</sup>COVER RIGHT HAND CORNER: HARRY MAYNOR, MILTON KAACK, WARREN DE BRUEYS, ERNEST WALL, JR., AND WOODROW GILHOPE, NEITHER COULD A TELETYPE BE LOCATED PERTAINING TO THE KENNEDY ASSASSINATION WITH THE NAME FURMAN ROSEN.
