- CONCERNING LEE HARVEY OSWALD WHO DID NOT EVER SHOW [REDACTED]
A PHOTOGRAPH OF OSWALD PRIOR TO THE ASSASSINATION.
AMDRUSE SAID HE HAD NEVER HEARD THE NAME LEE HARVEY OSWALD
BUT DID NOT KNOW WHO OSWALD WAS UNTIL AFTER THE ASSASSINATION
OCCURRED.

AMDRUSE SAID THAT AFTER THE ASSASSINATION OCCURRED
HE POSSIBLY MAY HAVE CONTACTED [REDACTED] CONCERNING THE
ASSASSINATION BECAUSE HE RECALLS THAT ALL [REDACTED] AND [REDACTED] WERE
REQUESTED TO BE CONTACTED ABOUT THE ASSASSINATION. HOWEVER,
IF HE DID, HE DOES NOT REMEMBER THE CONTENTS OF THE
CONVERSATION.

AMDRUSE SAID THAT HE WENT TO LANGUAGE SCHOOL IN
MONTICELLO, CALIFORNIA, IN JANUARY OF 1964 AND WAS TELEPHONICALLY
CONTACTED BY [REDACTED] FEW WEEKS AFTER ARRIVING AT MONTICELLO.
AMDRUSE TOLD [REDACTED] NOT TO CONTACT HIM SINCE HE WAS NO
LONGER IN THE MOBILE OFFICE. AMDRUSE SAID THAT THEY DID
NOT DISCLOSE ANY CASES BECAUSE AMDRUSE LEFT [REDACTED] UTR BEFORE
MOORE COULD TELL THEM ANYTHING.

AMDRUSE SAID THAT HE DID NOT TALK TO [REDACTED] ONE MORNING

AFTER THE ASSASSINATION ABOUT AN INTERVIEW WITH [REDACTED]
PRIOR TO THE ASSASSINATION OR THE SHOOTING TO [REDACTED] UP A
PHOTOGRAPH OF GENEVA PRIOR TO THE ASSASSINATION.

AMERKUS SAID THAT DURING THE TIME HE CONTACTED [REDACTED]
HE CONCLUDED [REDACTED] UNRELIABLE. THIS EVALUATION WAS BASED
BOTH ON HIS OWN PERSONAL OBSERVATIONS AND THROUGH INTERVIEWS
WITH OTHER INDIVIDUALS, INCLUDING ONE [REDACTED], A
GARDENING FIGURE IN THE MIDDLE AREA AT THAT TIME.
