ALL THE DALLAS ATTORNEY GENERAL NEEDS TO INDICT FIVE TO TWENTY FIVE UNITED STATES SECRET SERVICE AGENTS WHO KNOWINGLY AND WILLFULLY LED MR JOHN-F KENNEDY TO HIS DEATH WITH FULL KNOWLEDGE OF OSWALD WAITING IN THAT BUILDING NEAR THE DALLAS UNDERPASS WITH A LOADED RIFLE IS THE NAMES OF ALL THE SECRET SERVICE AGENTS ACCOMPANYING THE KENNEDY PARTY AND PARADE EXCEPT ALL THE AGENTS PERSONAL AND LOYAL TO MR KENNEDY WHO HAD BEEN TOLD THE NIGHT BEFORE TO GET DRUNK AND LAY-OUT IN BARS A NIGHT AND ALL NEXT DAY (TO GET RID OF THEM).

THE STATE OF TEXAS STATE ATTORNEY GENERALS OFFICE IN AUSTIN TEXAS TODAY RULED THAT THE STATUTE OF LIMITATIONS DID NOT EXPIRE ON THE JFK ASSASSINATION.

THE STATE OF TEXAS ATTORNEY GENERALS OFFICE RULED TODAY THAT FIVE TO TWENTY FIVE PERSONS WHO HAD MR KENNEDY IN TOW SO THAT HE COULD NOT NORMALLY ESCAPE AND THESE PERSONS DELIVERED JFK LIFE TO THE TARGET FOR A GUNMAN WHO HAD BEEN HIRED BY ANOTHER PERSON NOT A U.S. CITIZEN; THE SAID FIVE OR TWENTY FIVE AGENTS WERE CHARGEABLE WITH MURDER IF THEIR INTENT WAS TO GET MR KENNEDY MURDERED WHICH DID OCCUR.

THEREFORE, SENATOR INOUYA'S COMMITTEE COULD FURNISH THE NAMES OF THE SAID AGENTS TO THE DALLAS ATTORNEY GENERAL FOR INDICTMENT FOR MURDER.

MR CONNALLY IF HE WOULD VERIFY THAT HE WAS TOLD ONLY ONE SHOT WAS TO BE FIRED AND IF HE WAS NOT TOLD THE NAME OF THE ASSASSIN (MR OSWALD WHOSE DISCHARGE AFTER IT WAS GIVEN TO OSWALD BY THE ARMED SERVICES WAS CHANGED BY MR CONNALLY TO BAD DISCHARGE) COULD BE GRANTED IMMUNITY IF HE TELLS THE PROSECUTOR THE NAME OF THE PERSON WHO ASKED MR CONNALLY RIDE IN THE LEAD VEHICLE WITH MR KENNEDY TO MR KENNEDY'S DEATH.

THE PERSON WHO HAS BEEN IDENTIFIED AS KNOWING WHO THE STATE SIDE CIVILIAN SPONSOR OF MR KENNEDY'S ASSASSINATION HAS BEEN TALKING THAT ABOUT MR JIMMY CARTER RECENTLY MENTIONING THEM BOTH IN THE SAME AREA AND SAME CONTEXT HIS NAME IS ALAN ABLESON OF BARRONS MAGAZINE.

MY WHOLE STORY ABOUT THE KENNEDY ASSASSINATION IS THAT I INVESTIGATED IT IN 1961 AND REPORTED EVERY DETAIL OF IT TO THE U.S. ATTORNEY OFFICE AND TO THE F.B.I. AGENTS IN THEIR OFFICE SEVERAL TIMES ON DIFFERENT DAYS SEPARATED BY ONE MONTH EACH VISIT IN EARLY 1963

BEFORE IT OCCURRED AND IT HAPPENED EXACTLY AND EVERY DETAIL OF IT BECAUSE I HAD INTERCEPTED LEE HARVEY OSWALD (WITHOUT KNOWING HIS NAME IN DALLAS) IN 1961 WHILE ON A FLIGHT FOR THAT PURPOSE FROM S.A.C. 303R REFUELING SQUADRON IN BERMUDA. I OBTAINED THE WHOLE STORY AS TO THE SITE, THE BUILDING, THE WEAPON AND THE FLOOR FROM WHICH TO BE FIRED.

MY CONTENTION IS THAT THE SECRET SERVICE USED THIS INFORMATION WHICH I HAD GIVEN TO THE F.B.I AND TO THE U.S. ATTORNEYS OFFICE TO ASSASSINATE MR KENNEDY IN THE AFORESAID MANNER.

THEREFORE, THIS MAILGRAM IS THE LETTER THAT YOU, SENATOR INOUYA, REQUESTED FROM ME OVER THE TELEPHONE LAST NIGHT.

IN SUBSTANCE THE REPORT OF THE ASSASSINATION WAS SENT TO MR ROBERT KENNEDY BEFORE HE WAS ASSASSINATED AND THE SECRET SERVICE IN WASHINGTON D.C. FORGED MR ROBERT KENNEDY TO THE REGISTERED RETURN RECEIPT AND PLACED A NOTATION UNDER THE NAME U.S.S.S. THIS REGISTERED RECEIPT WAS GIVEN TO TWO F.B.I. AGENTS IN LAS VEGAS TWO DAYS AFTER BOBBY KENNEDY WAS ASSASSINATED WHEN THEY PICKED ME UP THAT MORNING AFTER THE ASSASSINATION. THESE TWO AGENTS TESTED THIS RECEIPT BY PUSHING ON IT WITH THEIR THUMB AND FINGERS HANDED IT BACK TO ME AND FLED.
