ON FEBRUARY 18, 1977, [REDACTED] MADE AVAILABLE TO THE DALLAS OFFICE COPIES OF 17 MISCELLANEOUS DOCUMENTS WHICH WERE PART OF A BOOK [REDACTED] WAS WRITING ON THE HUNT FAMILY AND WHICH [REDACTED] TURNED OVER TO [REDACTED] IN 1971. [REDACTED] ADVISED THAT THE COPIES HE IS MAKING AVAILABLE ARE THE ONLY PORTIONS OF THE [REDACTED] DOCUMENTS THAT ARE IN POSSESSION OF IRS THAT MIGHT PERTAIN TO THE HUNT FAMILY FEELINGS TOWARD PRESIDENT KENNEDY AND RELATED MATTERS.
