DEL MAR LANDS INCORPORATED. THE CITIZEN REPORTED A RUMOR THAT BING CROSBY OR H. L. HUNT MIGHT BE THE FINANCIAL POWER BEHIND DEL MAR LANDS. ADDITIONAL INFORMATION INDICATES [REDACTED] HAD ORGANIZED CRIME CONNECTIONS.

DALLAS WILL CONTINUE INVESTIGATION TO INCLUDE:

1. INTERVIEW OF HUNT RECEPTIONIST, BOBBY DRAKE, RE KNOWLEDGE OF A "SIGN OUT BOOK" OR "VISITOR LOG" REFLECTING THAT BRADING, ALSO KNOWN AS BRADEN, AND RUBY VISITED HUNT'S OFFICE PRIOR TO THE JOHN F. KENNEDY ASSASSINATION.

2. INTERVIEW OF NELSON BUNKER HUNT: A. RE HIS KNOWLEDGE OF EUGENE BRADING, ALSO KNOWN AS JIM BRADEN, JACK RUBY AND WILLIAM CIES.

B. RE ALLEGATION HE ORGANIZED A KILL SQUAD WHICH INVOLVED BRADEN.

C. RE ALLEGATION HE MAY HAVE RECEIVED A NOVEMBER 8, 1963, LETTER FROM LEE HARVEY OSWALD AND ANY KNOWLEDGE HE MAY HAVE CONCERNING THIS LETTER.

HANDLE ANY ADDITIONAL, OBVIOUS AND LOGICAL LEADS DEVELOPED AS THE INTERVIEW OF ADDITIONAL WITNESSES AND SUBMIT FOUR COPIES OF INVESTIGATIVE REPORTS. IF ANY QUESTION ARISES
