JACKSONVILLE, AT SHALIMAR, FLORIDA, CONTACT PUBLIC DEFENDER [REDACTED] AND ADVISE HIM THAT BUREAU WILL MET WITH SUBJECT.

JACKSONVILLE AT THE OKALOOSA COUNTY JAIL, CRESSVILLE, FLORIDA, CONTACT [REDACTED] AND DETERMINE WHAT INFORMATION HE HAS CONCERNING THE PRESIDENT JOHN F. KENNEDY ASSASSINATION.
