

(8) The staff and the members of the Committee may examine the original materials to which the staff has been given access as extensively as necessary, in the Hoover Building at Room 4171, during normal FBI business hours; upon reasonable notice, special arrangements may be made for access at other times.

(9) These procedures are adopted subject to satisfactory experience in implementation. If after a fair trial the procedures herein do not operate suitably in the view of either the SSC or the Attorney General, the procedures may be unilaterally set aside by either the SSC or the Attorney General and other appropriate and suitable methods of procedure undertaken.

Mr. Fallis advised that he had contacted SA Kevin Tucker, Deputy Special Agent in Charge of the Intelligence Division, U. S. Secret Service, regarding access to Secret Service files concerning the assassination of President John F. Kennedy. Mr. Fallis was advised that the Committee would be granted access only to Secret Service documents and would not be granted access to documents furnished to Secret Service by the FBI, CIA, and the Department of State consistent with the Third Agency Agreements.

Re: HOUSE SELECT COMMITTEE ON ASSASSINATIONS**

Mr. Fallis advised SA Coulson that Staff Director Richard Sprague of captioned committee was extremely upset over the inability to review FBI documents in Secret Service possession and that if this matter could not be resolved in the Committee's favor in the immediate future, that he (Fallis) would desire an appointment with Director Kelley to resolve the matter.

Contact with SA Tucker by SA Coulson revealed that the Secret Service intends to honor the Third Agency Agreement and not to release any FBI documents to the Committee. Tucker further advised that the Secret Service has between three and five cabinet drawers full of FBI documents.

YOU ARE, THEREFORE, INSTRUCTED TO REPLY BY TELETYPE SETTING FORTH YOUR INVENTORY REGARDING THE ABOVE LISTED JOHN F. KENNEDY ASSASSINATION FILES. IN ADDITION, YOU ARE REQUESTED TO ADVISE WHETHER ANY MATERIAL RELATIVE TO THE MARTIN LUTHER KING, JR., ASSASSINATION (MURKIN) AND THE ABOVE LISTED FILES RELATED TO THE JOHN F.
