PHILADELPHIA (AP) -- INSTEAD OF ANSWERING QUESTIONS, THE HOUSE
ASSASSINATION'S COMMITTEE'S RECENT REPORT ON THE MURDERS OF PRESIDENT
 KENNEDY AND THE REV. MARTIN LUTHER KING JR. WAS A "HOAX," ACCORDING
 TO THE COMMITTEE'S FORMER CHIEF COUNSEL, RICHARD SPRAGUE.

"ALL THEY DID WAS EVOLVE ANOTHER CONSPIRACY THEORY," SPRAGUE
 SAID IN AN INTERVIEW PUBLISHED IN THE SUNDAY BULLETIN.

THE FORMER ASSISTANT DISTRICT ATTORNEY SERVED AS THE COMMITTEE'S
 CHIEF COUNSEL FOR SIX MONTHS IN 1976-77 BEFORE RESIGNING IN A DISPUTE
 WITH THE PANEL'S LEADERS.

THE COMMITTEE'S 686-PAGE REPORT, RELEASED LAST WEEK, CONCLUDED
 THAT "IT WAS POSSIBLE ... THAT AN INDIVIDUAL ORGANIZED CRIME LEADER,
 OR A SMALL COMBINATION OF LEADERS, MIGHT HAVE PARTICIPATED IN A
 CONSPIRACY TO ASSASSINATE PRESIDENT KENNEDY."

THE COMMITTEE ALSO CONCLUDED THAT THERE WAS A "95 PERCENT"
 CHANCE THAT MORE THAN ONE GUNMAN FIRED AT KENNEDY AND THAT THE
 BROTHERS OF JAMES EARL RAY "PROBABLY" ASSISTED HIS FLIGHT AFTER THE
 MURDER OF KING.

"IT IS OUTRAGEOUS AND IRRESPONSIBLE FOR THEM TO SPEND \$5.4
 MILLION TO PRODUCE A REPORT THAT SAYS THIS 'MIGHT HAVE' HAPPENED OR
 THAT 'PROBABLY OCCURRED,'" SPRAGUE SAID.

SPRAGUE GAINED A NATIONAL REPUTATION AS THE DOGGED SPECIAL PROSECUTOR OF THE KILLERS OF UNITED MINE WORKERS INSURGENT JOSEPH YABLONSKI. HE TRACKED THAT CONSPIRACY THROUGH SEVERAL LAYERS OF THE UMW TO FORMER UMW PRESIDENT W.A. "TONY" BOYLE, WHO IS NOW IN PRISON FOR ORDERING THE ASSASSINATION.

SPRAGUE SAID HE HAD FORMED NO PERSONAL OPINION ON WHETHER THE ENNEDY OR KING DEATHS RESULTED FROM CONSPIRACIES.

PURPOSE:

It is recommended approval be granted for the return of 27 cartons of Xerox copies of the files of Lee Harvey Oswald from the Library of Congress previously furnished the Library of Congress for work prepared for the Select Committee on Assassinations.

DETAILS:

Mr. Nathan R. Einhorn, Chief, Exchange and Gift Division, the Library of Congress, Washington, D. C., by letter to Mr. James O'Neill, Acting Archivist of the United States, National Archives and Records Service (NARS), dated September 7, 1979, (copy attached) advised that the Library of Congress was in possession of 27 cartons of Xerox copies of FBI files on Lee Harvey Oswald dealing with the work for the Select Committee on Assassinations. Mr. Einhorn indicated the Library had no further use for this material and in seeking a suitable repository for it, requested a response from NARS as to whether they wanted the material transferred to the National Archives. The contents of this letter was brought to the attention of the Records Management Division by NARS personnel for comment on whether this material is of any value to the FBI.

It has been determined that the 27 cartons contain excised copies prepared by the FOIPA Branch and delivered to the Library of Congress on 1/19/78. A receipt is in file showing the transfer of this material to the Library of Congress. On September 27, 1979, Mr. Einhorn telephonically advised that the material he has at the Library of Congress is the Xerox copies which were delivered to the Library of Congress as indicated above. NARS intends to advise Mr. Einhorn that they have no interest in the Xerox copies and that the original documents are the only material of archival value, NARS will inform Mr. Einhorn that he could dispose of this material. Mr. Einhorn stated normally they would turn such material over to the GSA, who would give it to a contractor for reclamation purposes.

In the interest of avoiding the material being made public through improper disposal, it is recommended that the FBI obtain the material from the Library of Congress and return it to FBIHQ where it can be properly disposed of through the classified disposal system in the basement.

RECOMMENDATION:

That approval be given to reclaim 27 cartons of Xerox copies of the Lee Harvey Oswald files from the Library of Congress for the purpose of disposing of said material through the shredding operation located in the basement of FBIHQ.
