OF AN ALLEGED TELETYPE MESSAGE FROM THE BUREAU TO ALL SOUTHERN REGION OFFICES, ADVISING PRESIDENT KENNEDY WOULD BE ASSASSINATED IN DALLAS, TEXAS. WALTER DISCLAIMED KNOWLEDGE OF SUCH A MESSAGE. BUREAU KEPT ADVISED BY TELETYPES AND LHM'S DATED FEBRUARY 2, 1968, INCLUDING STENOGRAPHIC NOTES OF SAC SECRETARY WHO RECORDED INTERVIEW WITH WALTER.

JACKSONVILLE HAS NO PHYSICAL EVIDENCE IN ABOVE MATTERS. JACKSONVILLE AIRTEL TO DALLAS, APRIL 18, 1964, REVEALS A THOROUGH REVIEW WAS MADE OF ALL MATERIAL IN THE JACKSONVILLE FILES 89-18; 185-824; AND 44-346 (ASSASSINATION OF PRESIDENT KENNEDY; LEE HARVEY OSWALD AND JACK L. RUBY) AND ALL ALLEGATIONS ALLEGING SOME PERSON OR PERSONS OTHER THAN LEE HARVEY OSWALD COMMITTED THE ASSASSINATION OF PRESIDENT KENNEDY HAVE BEEN FORWARDED TO THE BUREAU. THIS INCLUDES NUMEROUS COMPLAINTS FROM PERSONS OF QUESTIONABLE MENTALITY AND WHO APPEAR MENTALLY UNSTABLE OR DISTURBED. ALL WERE FULLY RESOLVED.
