Kennedy and Dr. Martin Luther King, Jr. This access was granted in accordance with Assistant Attorney General Michael M. Uhlmann's letter of November 18, 1976, to Chairman Thomas N. Downing.

The Committee was established by House Resolution 1540, which terminated with the conclusion of the 94th Congress and in the absence of a new resolution, the Committee is no longer in existence under the rules of the House of Representatives. While a new resolution has been submitted, it has not been adopted. I am concerned that continued access to the material by staff members of captioned Committee constitutes a possible Privacy Act violation and request your advice on this matter. In the interim, we will continue to grant access in accordance with the aforementioned letter of November 18, 1976.
