This is to advise that a request to retain the services of former SA Robert P. Gumberling (retired) on an as needed basis based on his expertise of the John F. Kennedy assassination investigation has been approved.

Any request for the utilization of Mr. Gumberling's services will require prior Bureau approval for each instance. Mr. Gumberling's status will be that of a reemployed consultant and he will be compensated at the salary rate, exclusive of fringe, for the grade and step obtained at the time of his separation, less the daily rate of his retirement annuity. In Mr. Gumberling's case, the hourly rate without the fringe is \$15.18, or \$121.82 per day. The daily rate of the annuity is \$64.18, which means the Bureau will pay Mr. Gumberling \$57.64 per day for his services.

In addition to the above compensation he will be entitled to per diem and travel expenses as required for any necessary out of area travel. Any claim for reimbursement for his services should be made by executing standard form 1034, and for travel and per diem by executing standard form 1012.

**PURPOSE:** To advise that on the evening of 1/11/77 at 5:25 p.m., the Office of Legislative Affairs advised SA Lawn, Congressional Inquiry Unit, of the decision of the Department of Justice that representatives of the House Select Committee On Assassinations immediately should be denied access to the files of the FBI, based upon Privacy Act considerations, until such <sup>time</sup> as the HSCA is recreated by the 95th Congress. This conversation was immediately confirmed through follow up telephonic contact with the Office of Congressional Affairs, Legal Counsel Division, and again with the Office of Legislative Affairs, Department of Justice.

Thereafter on Wednesday morning 1/12/77 at 9 a.m., two representatives of the HSCA, on arrival at FBIHQ, were advised of the decision of the Department of Justice temporarily to deny access to the HSCA because of Privacy Act considerations, until such time as the HSCA is reestablished by the 95th Congress. These representatives of HSCA were advised that a letter would be forthcoming from the Attorney General in this regard.

ations, until such time as the HSCA is recreated by the 95th Congress. This decision furnished by Mr. Callaghan was confirmed in follow up telephonic contact between SA Lawn and SA Danny O. Coulson, Office of Congressional Affairs, Legal Counsel Division, and thereafter between SA Lawn and Mr. Callaghan and Mr. Uhlmann, Office of Legislative Affairs. Mr. Callaghan further advised that a letter to the Chairman of the House Select Committee On Assassinations would be prepared in this regard by the Department.

At 9 a.m. on Wednesday, 1/12/77, Mr. Ralph Locke and Mrs. Mereto Rosen, representatives of HSCA, arrived at FBIHQ and were advised that access to FBI files was being temporarily denied them based upon a decision by the Department of Justice, which decision was reached because of Privacy Act considerations. They were informed that this denial of access was temporary until such time as the HSCA was reestablished by the 95th Congress. Mr. Locke then contacted his office and advised that they should not send any additional personnel to FBIHQ to review files. Locke expressed his appreciation for past amenities and with his associate, Mrs. Rosen, was escorted from FBIHQ.

The purpose of this memorandum is to advise of a letter from Attorney General Levi to Congressman Henry B. Gonzalez (Texas) informing him of the Attorney General's decision to restrict the access to FBI materials by staff members of this former Committee.

DETAILS:

Enclosed is a letter dated January 12, 1976 (sic), to Congressman Henry B. Gonzalez from Attorney General Levi regarding captioned Committee. Pursuant to a request by Assistant Attorney General Michael M. Uhlmann, Office of Legislative Affairs, SA Danny O. Coulson, Office of Congressional Affairs, Legal Counsel Division, and Deputy Assistant Attorney General Larry Callaghan on 1/12/77, prepared a draft letter for the Attorney General's signature to Congressman Gonzalez. This letter advised of the Attorney General's concern in continuing to allow staff members of captioned Committee access to FBI material regarding the assassinations of President John F. Kennedy and Dr. Martin Luther King, Jr., inasmuch as this Committee has not been recreated by the 95th Congress. In his letter the Attorney General advised that the Bureau would continue processing material for the use of the Committee and access would be granted as soon as the 95th Congress reestablishes the Committee. The Attorney General pointed out to Congressman Gonzalez that much of the material in the files of the FBI pertaining to these investigations is covered by the Privacy Act, 5 U.S.C., Section 552(a).

Alan Parker, Chief Counsel, Subcommittee on Civil and Constitutional Rights of the House Judiciary Committee, advised SA Danny O. Coulson on 1/12/77, that the House of Representatives is currently considering several options regarding the reestablishment of this Committee. He advised that one option being considered is to recreate the Committee along certain guidelines that will outline certain specific purposes and techniques that the Committee must follow. A second option being considered is to have a standing committee of Congress review the matter to determine if a full investigation of these assassinations is actually warranted. A third option being considered is the passage of a bill in the House and Senate to establish a blue ribbon panel in the Executive Branch to look into the need for further examinations of these assassinations.

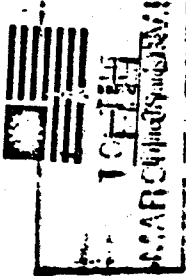
