The request was received by the YBI on September 11, 1978.

The mentioned fingerprint card was received by the FBI from the New Orleans: Police Department on August 12, 1963.

A search of records at YBI Headquarters (YBIHQ) discloses that, on April 2, 1964, the Warren Commission "...requested a copy of the Marine Corps fingerprint card of Oswald from our files and a copy of the fingerprint card of Oswald we received from Dallas showing he was dead . " No retrievable document indicates that the Warren Commission requested the New Orleans Police Department's fingerprint card or that the FBI provided same.

It is noted that the Warren Commission was in possession of a fingerprint card on Lee Harvey Oswald, obtained at the time of his arrest in New Orleans, which it received directly from Louisiana gtate authorities.

Where information is not provided, it is either not retrievable from FBIHQ files or is not produced pursuant to the Memorandum of Understanding.




