AROUND FIFTY-FIVE. HIS EYES HAVE A STARE AND YOU FEEL LIKE HE IS LOOKING THROUGH YOU. HE IS STAND-OFFISH, HE DOES NOT MIX IN THE PARTY. HE IS A SLENDER MAN, AROUND FIVE FT. TEN TO SIX FT. HE HAS DARK HAIR THAT APPEARS TO BE A CREW CUT COMING OUT AS IF IT IS NOT EVEN ON HIS HEAD. HE HAS A SIDE BRIM OR TWINK ON THE LEFT SIDE OF HIS MOUTH, PULLS HIS MOUTH BACK LIKE A SMILE. WHEN HE PULLS HIS MOUTH BACK TO SIDE, SPACE IS NOTICEABLE BETWEEN UPPER TEETH. THIS SPACE CANNOT BE SEEN EXCEPT WHEN HIS MOUTH IS DRAWN BACK. HE HAS A SMALL GOLD BAND ON HIS RIGHT LITTLE FINGER. IT IS PLAIN GOLD AND MIGHT POSSIBLY HAVE AN INITIAL ON IT. HE IS A FEISTY GUY, BEING CONSERVATIVE. USUALLY WEARS A SUIT. SHE SAW HIM ONE TIME WITH A REAL SPLASHY SPORT SHIRT ON. SHE HAD NEVER SEEN ONE LIKE IT BEFORE OR SINCE. IN OTHER WORDS, HE DIDN'T BUY IT A GOOD WHILE.

SHE HEARD HIM MENTION NAME "JIM MORING," WHO IS SUPPOSED TO BE A MEMPHIS MAN, AND THE NAME OF DUKE, WHO IS SUPPOSED TO BE A MEMPHIS PARTY. FROM WHAT SHE COULD FIND OUT ABOUT HIM, HE IS FROM AROUND BIRMINGHAM, AND ATLANTA. HE TAKES GREEN BILLS AND TRAVELS BETWEEN BIRMINGHAM, ATLANTA, AND CALIFORNIA, AND IS MIXED UP WITH SOME SUPPOSED TO BE BIG TIME SAFE BURGLARS, ONE

INDICATES THAT [REDACTED] A FORMER RESIDENT OF MEMPHIS, AND [REDACTED] IN SERIOUS AUTOMOBILE ACCIDENT MARCH TWENTY SIX, SIXTYEIGHT, AND SUPPOSED TO BE IN METHODIST HOSPITAL, MEMPHIS, AT THIS TIME. ARRANGEMENTS ARE BEING MADE TO INTERVIEW THEM.

[REDACTED] IS REPORTED TO HAVE A RESIDENCE IN PANAMA CITY, FLA., AND HIS FATHER IS SUPPOSED TO OPERATE A CHARTER BOAT OUT OF DESTIN, FLA.

THE LEAD MATERIAL FOUND IN A REVIEW OF THE FOREGOING THAT IS FULLY AND PROMPTLY EXPLORED IN MEMPHIS DIVISION. WE KNOW OF NO "WALLACE FOR PRESIDENT" ORGANIZATION IN TENN. BUT ARE MAKING FURTHER CHECKS CONCERNING THIS INTEREST EXHIBITED BY GALT. MEMPHIS OFFICE SHOULD LIKEWISE EXPLORE POSSIBILITY THAT GALT HAS BEEN INVOLVED IN WALLACE ACTIVITY IN PLACES OTHER THAN CALIFORNIA.
