AT DALTON, GEORGIA

- 1) Will identify, locate and interview [REDACTED] who is employed at [REDACTED] thoroughly regarding trip taken in latter part of March, 1968, and first part of April, 1968, together with [REDACTED] (protect name of [REDACTED] at all times) and [REDACTED] to Atlanta, Ga., Chattanooga, Tennessee, Knoxville, Tenn., and Memphis, Tenn., and back to Chattanooga, Tenn., and Dalton, Ga.
- 2) Will determine from [REDACTED] where he, [REDACTED] and [REDACTED] stayed in Memphis and purpose of their trip to Memphis, Tenn.
- 3) Will determine from [REDACTED] where he heard about murder of Dr. MARTIN LUTHER KING.
- 4) Will determine where [REDACTED] and [REDACTED] went after leaving Chattanooga, Tenn., after hearing of death of KING.
- 5) Will determine whether or not 1965 Mustang disposed of and to whom, so that 1965 Mustang can be examined to determine if a police radio ever was installed in it.
- 6) Will identify, locate, and interview [REDACTED] who lives on dirt road six miles out Chatsworth Highway from Dalton, Georgia, who is said to be in U.S. Army, at present, along same lines as [REDACTED]

KNOXVILLE

AT CHATTANOOGA, TENNESSEE

- 1) Will contact the Florida Hotel to determine dates on which [REDACTED] protect at all times were registered in the Florida Hotel. (Note [REDACTED] and [REDACTED] were allegedly registered in Florida Hotel on 2/separate occasions in late March, 1968, and early April, 1968.)
- 2) Will contact a porter, [REDACTED] who allegedly works at Florida Hotel to determine if he knows [REDACTED] and [REDACTED], and if he told them of death of Dr. MARTIN LUTHER KING.
