A review of the New Orleans files by SA EARL L. HASSELL, JR., on November 29, 1963, for information pertaining to STEVE NAISHALL, 150 Mehle Street, resulted in location of information being set forth as follows:

Review of New Orleans file 62-0-14883 entitled "STEVE MARSHALL - MISCELLANEOUS" reflected that on July 24, 1961, STEVE MARSHALL telephonically contacted Eastern Airlines, New Orleans, Louisiana, and at that time furnished his address as 150 Mehle Street, Arabi, Louisiana, telephone number ED 1-2789. MARSHALL at this time advised Eastern Airlines officials that he could recover the Eastern Airlines airplane which had been hijacked after it took off at Miami and had been forced to land at Havanna, Cuba. MARSHALL stated he wanted \$250,000.00 to recover the airplane.

New Orleans file 105-1640 entitled "STEVE MARSHALL - IS - CUBA", shows that a STEVE MARSHALL 150 Mehle Avenue, Arabi, Louisiana, telephone number ED 1-2789, on October 3, 1961 telephonically contacted Mr. P. LOUIS ADAMS, personnel director, Veterans Administration Hospital, New Orleans, Louisiana, and stated he, MARSHALL, had read an article in the newspaper which indicated that certain doctors who were being called for active duty by reserve units were being replaced by Cuban refugee doctors. MARSHALL advised that he wanted to talk to these Cuban doctors and see if they had any mutual interests and he wanted to know if they would be interested in returning to their homeland, resuming their practice and joining their families.

MARSHALL stated he felt if he could get into Cuba he could do more in three days with the proper equipment then 3,500 men and three years had accomplished. He stated he could get Castro out of Cuba.

On November 14, 1961 St. Bernard Parish Sheriff, Chalmette, Louisiana, advised STEVE MARSHALL, 150 Mehle Avenue, Arabi, Louisiana, had a criminal record in his office,

STEVEN MARSHALL, 150 Mehle Street, Arabi, Louisiana, was interviewed on May 14, 1963, by SA DONALD J. STORAKER. MARSHALL advised he thought of the idea of ordering surplus supplies from Government agencies and selling these supplies to police departments. He stated he was interested in guns and offered to sell to the New Orleans Police Department a quantity of M-1 carbines which he intended to order if he obtained an order from the New Orleans Police Department. MARSHALL advised he did not have weapons in his possession and since he had no money wanted to purchase the rifles on consignment.
