RE JACKSONVILLE TEL TO NEW ORLEANS, DECEMBER SEVEN LAST AND
NEW ORLEANS TEL TO DALLAS AND JACKSONVILLE DECEMBER SEVEN LAST.

RE AUBERT CURTIS GRIFFIN.

RALPH A. HAYES, AKA ARCHIE, TWO ZERO ONE EAST JACKSON STREET,
LAUREL, MISS., STATES AUBERT CURTIS GRIFFIN, WHOM HE HAS KNOWN
FOR SEVERAL YEARS CAME TO HIS HOME AROUND NINE THIRTY PM, NIGHT OF
NOVEMBER TWENTY LAST. STAYED THERE UNTIL ABOUT ELEVEN THIRTY PM,
AT WHICH TIME HE TOOK GRIFFIN TO THE EDWIN HOTEL, WHERE GRIFFIN
CLAIMED TO BE STAYING. DID NOT SEE OR HEAR FROM GRIFFIN ANY MORE
UNTIL HAYES WIFE RECEIVED A TELEPHONE CALL SHORTLY AFTER MIDNIGHT,
NOVEMBER TWENTY THREE LAST, FROM THE JONES COUNTY COMMUNITY HOSPITAL.
THE HOSPITAL AUTHORITIES ADVISED THAT GRIFFIN HAD BEEN ADMITTED THERE
AND WANTED HAYES TO STOP BY SATURDAY MORNING. HAYES TRIED TO
LOCATE GRIFFIN EARLY THAT DATE AT THE HOSPITAL BUT WAS TOLD HE WAS
NOT THERE.

ON NOVEMBER TWENTY SEVEN LAST, HAYES LEARNED THAT GRIFFIN WAS
AT HOSPITAL AND WAS BEING RELEASED THAT DATE. HAYES WIFE WENT TO
HOSPITAL TO VISIT GRIFFIN BEFORE NOON. GRIFFIN/S FATHER WAS THERE
AND WAS TAKING HIM HOME. NO RECORD OF GRIFFIN AT EDWIN HOTEL.

PERSON WHO MAY HAVE BEEN GRIFFIN REGISTERED AT DELMAR COURTS, LAUREL, NIGHTS OF NOVEMBER NINETEEN, TWENTY, LAST, UNDER NAME APPEARING TO BE REX C. AYSTERRAPETER, FOUR ONE EIGHT HIGH STREET, JACKSON, MISSISSIPPI. CLAIMED TO BE REPRESENTING THE HARRISON GUARD, TOWN NOT GIVEN.

ROBERT BRASHIER, BRASHIER/S AUTOMOTIVE SERVICE, STATES HIS FATHER WAS IN ROOM WITH GRIFFIN AT THE JONES COUNTY COMMUNITY HOSPITAL. GRIFFIN TOLD BRASHIER HE HAD BEEN WORKING IN HATTIESBURG, MISS., AT POWDER COMPANY AND WAS ON HIS WAY TO MERIDAN, MISS., WHEN HE GOT SICK EARLY MORNING OF NOVEMBER TWENTY THREE. HE HAD TO STOP IN LAUREL AND REGISTER AT THE HOSPITAL.

BRASHIER STATES NO PERSON VISITED GRIFFIN UNTIL SHORTLY BEFORE HIS DISCHARGE.
