The call was made by a Mr. NORMAN SPARY. Mrs. OSWALD also learned that the Shaw Estes Construction Co. of Dallas has the number Riverside 9-9826. She also learhed that this number is not listed under the Shaw Estes Co. -Mrs. OSWALD is not acquainted with anyone by the ----name of NORMAN SPARY and does not know why he would try and contact her unless he must have had some information concerning the assassination of President KENNEDY.
