ON DECEMBER SEVEN, LAST, TO TRY TO GET HIM TO CONTACT FBI TO OBTAIN INFORMATION ABOUT OSWALD'S ALLEDGED SHOOTING INTO GENERAL WALKER'S HOME. HE STATED WATTS WAS ENDEAVORING TO ASCERTAIN WHEREABOUTS OF OSWALD'S WIFE TO INTERVIEW HER ABOUT STATEMENTS IN THE PRESS REGARDING OSWALD'S ALLEDGED SHOOTING AT GENERAL WALKER. [REDACTED] STATED HE TOLD WATTS THE FBI COULD NOT GIVE HIM ANY INFORMATION [REDACTED] STATED WATTS' TACTICS ARE FOR PUBLICITY PURPOSES AND THAT IF MARINA OSWALD WAS LOCATED BY WATTS, GENERAL WALKER WOULD CALL ANOTHER PRESS CONFERENCE IN EFFORT TO CASH IN ON THE PUBLICITY THAT MIGHT RESULT. [REDACTED] STATED THE ONLY WAY GENERAL WALKER CAN KEEP HIMSELF QUOTE ALIVE UNQUOTE IN THE PUBLIC EYE IS THROUGH THE NEWSPAPERS. P.
