RE DALLAS TELETYPE JAN. TWENTYSIX LAST AND MY TELCALL THIS DATE RE ARTICLE IN SAGA MAGAZINE BY WILLIAM W. TURNER.

AS REFLECTED IN RETEL, CAPT. GLEN KING REMEMBERED TURNER HAVING CONTACTED HIM PRIMARILY BECAUSE AN FBI AGENT NOTIFIED HIM AFTER THE CONTACT THAT TURNER WAS AN EX FBI AGENT WHO HAD LEFT THE BUREAU UNDER A CLOUD AND WARNED HIM ABOUT THIS INDIVIDUAL. IT HAS BEEN DETERMINED THAT THIS AGENT WAS JOHN J. FLANAGAN, ASSIGNED OKLAHOMA CITY. I TELEPHONICALLY CONTACTED

FLANAGAN AND HE STATED THAT SOMETIME DURING AFTERNOON OF NOV. TWENTYFIVE LAST, HE DID SEE TURNER, WHOM HE HAD KNOWN WHEN TURNER WAS ASSIGNED TO THE OKLAHOMA CITY OFFICE, AND KNEW THAT HE HAD CONTACTED CAPT. GLEN KING. HE CALLED CAPT. KING INTO ANOTHER OFFICE FROM HIS OFFICE AND ADVISED HIM OF THE FACT THAT TURNER WAS AN EX FBI AGENT AND THAT HE HAD LEFT THE BUREAU UNDER SOMEWHAT OF A CLOUD AND THAT HE SHOULD BE CAREFUL WITH WHAT INFO HE GAVE HIM. HE ALSO DETERMINED AT THIS TIME THAT TURNER WAS ALLEGEDLY REPRESENTING MC FADDEN PUBLICATIONS.

FLANAGAN THEN STATES THAT SHORTLY THEREAFTER HE TELEPHONED THE FBI OFFICE FROM THE POLICE DEPT. AND GOT ME ON THE PHONE AND HE ASKED ME IF I KNEW THE DETAILS OF THE TURNER DASH WESLEY GRAPP SITUATION. I SUPPOSEDLY TOLD HIM THAT I WASN'T TOO FAMILIAR WITH IT, BUT I KNEW A LITTLE SOMETHING ABOUT IT. HE THEN SAID, WELL, LET ME TALK TO INSPECTOR MALLEY AS I KNOW HE IS VERY FAMILIAR WITH IT. HE STATES HE THEREAFTER TALKED TO INSPECTOR JAMES R. MALLEY AND TOLD HIM OF THE FACT THAT TURNER WAS THERE REPRESENTING MC FADDEN PUBLICATIONS AND THAT HE HAD TOLD THE POLICE ABOUT HIM. FLANAGAN ALSO STATES HE MENTIONED THIS TO INSPECTOR MALLEY IN THE OFFICE LATER THAT NIGHT BUT DID NOT PREPARE ANY MEMO I PERSONALLY HAVE NO INDEPENDENT RECOLLECTION OF THIS PARTICULAR CALL. OF COURSE, THIS WAS THE DAY FOLLOWING THE KILLING OF OSWALD AND THERE WERE LITERALLY HUNDREDS OF REPORTERS IN TOWN CALLING THE OFFICE, AND BOTH INSPECTOR MALLEY AND I WERE CONTINUALLY ON THE PHONE EITHER TO WASH. OR ANSWERING LOCAL CITIZENS' CALLS AND CALLS FROM VARIOUS REPRESENTATIVES OF NEWS MEDIA. I AM NOT SAYING I DIDN'T RECEIVE THE CALL, BUT IF I DID, I DID NOT AT THE TIME RECOGNIZE THE SIGNIFICANCE OF IT. IN VIEW OF THE FACT THAT TURNER WAS ONE OF SEVERAL HUNDRED REPRESENTATIVES OF VARIOUS NEWS MEDIA FROM ALL OVER THE WORLD HERE, THERE WAS NO

REASON FOR THE POLICE OR ANY OTHER SOURCE TO ADVISE ME OF HIS PRESENCE AND IT DOES NOT APPEAR THAT HE WAS MENTIONING THE FACT THAT HE WAS AN EX FBI AGENT, AS THE ONLY WAY THIS CAME TO LIGHT WAS THROUGH AGENT FLANAGAN TELLING THE POLICE OF IT.

AS NOTED IN RETEL, TURNER WAS APPARENTLY REGISTERED IN THE SHERATON DALLAS HOTEL FROM NOV. TWENTYFIVE TO NOV. TWENTYSEVEN, SIXTYTHREE. A CHECK OF OTHER HOTELS IN DOWNTOWN DALLAS WAS NEGATIVE. CHECK OF MOTELS IMMEDIATELY SURROUNDING THE AIRPORT WAS NEGATIVE. RECORDS OF SHERATON DALLAS HOTEL ARE BEING CHECKED TO DETERMINE LONG DISTANCE TEL CALLS AND THEY WILL BE CHECKED OUT. CHECK OF AMERICAN AIRLINES ON THEIR FLIGHTS FROM SAN FRANCISCO TO DALLAS DURING PERTINENT PERIOD IS BEING MADE IN ATTEMPT TO DETERMINE EXACTLY WHEN HE ARRIVED HERE, SINCE ONE OF HIS STATEMENTS INDICATES HE WAS HERE SHORTLY AFTER THE ASSASSINATION. A CHECK OF DELTA AIRLINES REFLECTS THAT ONE M. TURNER PROCEEDED BY UNITED AIRLINES FROM SAN FRANCISCO TO LOS ANGELES ON NOV. \* TWENTYTHREE, CONNECTED WITH DELTA, ARRIVING IN DALLAS AT FOUR THIRTY PM, NOV. TWENTYTHREE. CHECK OF AMERICAN AIRLINE AND RECORDS OF HOTEL WILL BE CONTINUED AND BUREAU ADVISED.
