IRVING KAUFTAN, Beverly Hills Hotel, 9641 Sunset, Beverly Hills, California, and bearing the return address, KARL MIK. 3703 Monon Street, Los Angeles 27, California. The envelope contained a four page pamphlet entitled "The Rosenberg Story", which attempted to justify the actions of Julius and ETHEL ROSENBERG, in giving atomic secrets to the soviets. The files contained no additional information identifiable with the subject.

The files of the Los Angeles Registrar of Voters, as checked 1/28/64, by IC FREDRICK E. BECKER, revealed that KARL ZERK, 3703 Monon Street, Los Angeles, California, was born in Czechoslovakia. He acquired citizenship by decree of the court on 4/14/43, at Camp Hale, Colorado, Affidavit of Registration number E-962292, Court Docket number 547967. The record further revealed that ZEPK was a textile engineer. The date of his last registry was 4/22/48, as a Democrat.

Records of the Los Angeles Retail Merchants Credit Association, Los Angeles, California, as caused to be checked 1/28/64, by IC GERALD A. BOSWELL, revealed that KARL ZERK had been on file since 9/26/55. His employment was listed as
