He said no attempt is made to remove forms to which an address is not attached as these are later discarded 2.57 C. 2. 0 by postal authorities and the operation is too rapid to attempt to examine the forms as they emerge from the machine. He said that marking pens with various ink colors are available throughout the area, which includes the addressing machines, and he was unable to suggest anyway in which it might be possible to identify the employee who had written on the form in question.
