I MIGHT GET TO ESCORT THE OUTSTANDING CADETS OF SIX STATES THIS YEAR ALLSO, SAME AS LAST YEAR WHEN WE WENT TO CAPE KENNEDY, TO SEE THE LAUNCHING OF GEMINI TEN.
