General Walker stays in the house at cht alons. Investigation reveals that an unknown assailant in all likelihood red the shot from the alley directly north of the rear part of the house. Investating officers found a very small chipped edge of the top portion of the rear nce. This small chipped portion indicated that something had been laid on this and very recently, as this was a fresh chip. In lining up the path of the bullet, would indicate that the shot was fired from just below the chipped portion of fonce. The bullet struck the window frame near the center locking device. on the point where the bullet hit the window frame to the point where it struck well is a downward trajectory. The back yard is an up-grade to the alley. The ice in the rear of the house at the alley is a lattice type fence made out of d approximately 1x6, with approximately 8" open spots. It is the investigating icors opinion that the shot was fired from just below the top edge of the feace. Walker home is adjoined by a parking lot of a church to the east. The alley is into the rear part of the parking lot. The alley then takes up in a northerly ection into Kewman street. The witness, Kirk Coleman, lives at the north east mer of the Walker property just across the alley and directly across north from church parking lot. This person has not been contacted by us as he is a sool boy, but will be contacted at a later time as he could furnish valuable formation from which he observed the incident. An interview with the volunteer kers revealed that they had not received no crank calls or letters preceeding incident. An interview with Mr. Surrey reveals that two white men in a 1963 d, dark purple or dark brown parked in the alley directly behind the complainant's so just off of Avon: ale street. These persons were witnessed getting out of car and walking up to the proporty line and snoking the place over. Hr. Surrey ame suspicious of these subjects and followed the car away from the location in attempt to get a license number. Hr. Surrey states that there was no license te on this car either front or rear, possibly this was a new car. A thorough rch of the premises revealed no spent cartridges , no tracks or other evidence value. The neighbors dog to the west of the Walker property is a fanatical ker but on this incidence did not make a sound. Gen. Walker recently accepted position of Military Editor for a monthly magazine the American Mercury and traveled extensively since. It is assumed the suspects had a minimum of clodge concerning the complainant's activities. From where the complainant and from where the shot was fired from the distance is approximately thirty a to forty yards with a clear view as there are no window shades.
