- 7⁰²_{am} - 9⁰⁰ No activity
- 9⁰⁷_{am} - Black '59 Daimler, with '63 Texas license PB 871, left near of residence, 1405 7 Brookcrest. One unknown white male driving car - no passengers.
- 9⁰¹ - 9³¹ No activity
- 9³² - Black '59 Daimler returned, via alley, to near of residence 1405 7 Brookcrest.
- 9³² - 9⁵⁴ - No activity
- 9⁵⁵ - Gray '59 Willman, with Texas license PB 872, left near of residence. One white male, unknown, driving. Subject's small child only passenger. Driver identified as Deelan P. Ford.

2:10 PM - Mrs. Debra P. Ford, Marina Oswald, and child accompanied by unknown white male, age about 33, 6'0", 190#, carrying brown attache case, got off elevator, in lobby of building. After discussion in garage, went to building parking garage.

2:17 PM Mrs. Ford, Marina Oswald, child and unknown white male, got into 1958 white Thunderbird, bearing T. Texas license NK5925. Drove to Post Office Annex parking lot, 100 block South Houston. All four departed car and entered Post Office Annex building.

2:27 PM Mrs. Ford, Marina Oswald, her small child and unknown white male observed to depart the Post Office Annex Building and re-enter the 1958 white Thunderbird. With the unknown white male driving they proceeded to the Humble Sta half way service area on the Dallas-Fort Worth Turnpike.

3:02 PM Unknown white male observed to depart the car and enter the station.

- 5³³ pm - Parked in 300 block, College St., Gr. Prairie - unknown white male departed car, Mrs. Ford, Marina Oswald - child remained in car.
- 6⁰⁷ pm - Unknown white male observed leaving Thor-Kin Professional Bldg., 300 block College St. Got into Thunderbird and drove to Kiji's Coffee Shop on Main.

- 6²⁸ pm - Unknown white male left Kiji's, got back into car, and proceeded towards 300 block College.
- 6³² pm - Unknown white male went into Thor-Kin Professional Bldg.
- 6³⁵ pm - Unknown white male left 302 College St., Gr. Prairie, got into car, proceeded towards Dallas on toll road.
