**PERSONAL RECORD**

**EL PASO TEXAS FEDERAL CONTRACT SCHEDULE NUMBER**

- ...for nonresidential COMMERCIAL EMPLOYMENT SERVICE will hereinafter be called COMMERCIAL.

2. This contract shall remain in force for a period of three years and as long thereafter as I except services rendered by COMMERCIAL.

3. I agree to pay to COMMERCIAL, at Fort Worth, Texas, for any position or positions presented, either directly or indirectly, through COMMERCIAL, and accepted by me, a FEE of 10% (ten percent) of the first \$10,000.00 of the compensation received or to be received by me for said first month shall be included in the fee. The first \$10,000.00 shall be calculated on the basis of hour and associated costs or non-receipt of one year. Payment of the fee shall be made on a monthly basis. Party (2) (per) 10% of each payment made to me during such period shall be paid as soon as it is received by me, and in all events the full fee shall be paid within thirty (30) days after acceptance of such position.

4. If I accept a position with an employer to whom I was referred, either directly or indirectly, by COMMERCIAL, within a period of one year from the date of my original contact with such employer, I agree that such position was presented through information furnished me by COMMERCIAL, and that I will pay the fee provided for in Section 3 of this Contract.

5. If through information furnished me by COMMERCIAL I am accepted by an employer on a trial basis for a short period of time, the percentage of the position depending upon my or my ability, I agree that such position shall be considered a permanent position and that I will pay the fee provided for in Section 3 of this Contract.

6. I agree that when COMMERCIAL refers me to a prospective employer that I will tell them that before COMMERCIAL, if any other employment agency or person has referred such prospective employer to me.

7. If any employer to whom I am referred by COMMERCIAL, does not employ me but to some extent, to another employer and I present a position on a month's basis, of such client, I agree that such position was presented through information furnished me by COMMERCIAL, and that I will pay the fee provided for in Section 3 of this Contract.

8. All past due payments due under this contract shall bear interest from maturity at the rate of 10 per cent per annum, and in the event a suit is brought for collection thereof I agree to pay a reasonable attorney's fees and court costs.

9. I agree that I will keep my and all information given to me by COMMERCIAL, relative to the presenting of my position strictly confidential and will not divulge the same to any other employment agency or to any other person.
