**PLEASE READ THE FOLLOWING CONTRACT CAREFULLY BEFORE SIGNING**

- The commercial **COMMERCIAL EMPLOYMENT SERVICE** will hereafter be called **COMMERCIAL**.
- This contract shall remain in force for a period of three years and so long thereafter as I accept services rendered by **COMMERCIAL**.
- I agree to pay to **COMMERCIAL**, at Fort Worth, Texas, for any position or positions secured, either directly or indirectly, through **COMMERCIAL** and accepted by me a FEE of forty (40) per cent of the agreed base month's salary. All overtime compensation or other compensation received or to be received by me for said base month shall be included as a part of such salary. The base fee month shall be one divided on the basis of four and one-half weeks or one-twelfth of one year. Payment of the fee shall be made on the following: Forty (40) per cent of such payment made to me during each period shall be paid to me as soon as it is received by me, and to all extent the full fee shall be paid within thirty-two (32) days after completion of such position.
- If I accept a position with an employer to whom I was referred, either directly or indirectly, by **COMMERCIAL** within a period of one year from the date of my original contract with such employer, I agree that such position was procured through information furnished me by **COMMERCIAL** and that I will pay the fee provided for in Section 3 of this contract.
- If through information furnished me by **COMMERCIAL** I am accepted by an employer as a trial basis for a short period of time, the percentage of the position depending upon me or my ability, I agree that such position shall be considered a permanent position and that I will pay the fee provided for in Section 3 of this Contract.
- I agree that when **COMMERCIAL** refers me to a prospective employer that I will at that time inform **COMMERCIAL** if any other employment agency or person has referred such prospective employer to me.
- If any employer to whom I am referred by **COMMERCIAL** does not employ me but I am referred to another employer and I procure a position as a result of such referral, I agree that such position was procured through information furnished me by **COMMERCIAL** and that I will pay the fee provided for in Section 3 of this Contract.
- All past due payments due under this contract shall bear interest from maturity at the rate of 10 per cent per annum, and in the event a suit is brought for collection thereof I agree to pay a reasonable attorney's fee and court costs.
- I agree that I will keep any and all information given to me by **COMMERCIAL** relative to the procuring of my position strictly confidential and will not divulge the same to a third party or any other employment agency or to any other person.
