Operation of Sanctions Imposed by Section 213(g) of the Immigration and Estionality Act in Case of Mrs. Earing H. Oscald

It has come to the attention of SDV that in approving the petition granting Mrs. Farina H. Osmald non-quota status the San Antonio District Office of IIS did not include a univer of the sanction against the issuence of the visa imposed by Section 203(g) of the Innigration and Nationality Act. It would, therefore, be measury for Mrs. Osmald to proceed to a third country and there apply for a United States visa instead of receiving a visa at Moscow when her hunbind, Lee Harvey Osmald, is documented for a return to the US as an American citizen.

Lee Marvey Oswald is an American citizen the defected from
the US and decided to reside permanently in the Soviet Union.
Although he made known to the Embarry his original intention to
remomes American citizenship, he never completed the formalities.
When he became distillusioned with life in the Soviet Union, he
requested paraport facilities to return to the US. After due conmideration the Paraport Office made the decision that Oswald is
still an American citizen; the Embarry has been authorized to issue
him a passport for return to the US; and SCS has authorized a loan
of \$500 to emable him to travel to the US with his Soviet wife and
recently born child.


SOV believes it is in the interest of the US to get Ice
Earway Osmald and his family out of the Soviet Union and on their

whose actions are entirely unmedictable, Osmald may well refuse to
leave the USUR or subsequently attempt to return there if we should

Obviously, this would weaken our Erbassy's position in encouraging positive Soviet action in other cases involving Soviet citizen relatives of US citizens.
