

Diary October morning

Oct. 31. 1857.

12-26 arrived to "BOLIVIAN REPUBLIC", two days, and went to
at the Embassy. One states as I approach entrance of the
Embassy and says "MISTER!" I smile and say by account.
He motions me to pass inside his office. There can be little
doubt's still in his mind right this moment. Went directly
to his office and was admission written down & bill paid.
Entering I find the office of Consulor & his young secretary
& wife. A secretary busy thing looks up. "What she says
"I'd like to see the Consulor himself?" I say. "will you wait
the Consul or Consulor Please?" he says & don't going back to him.
"Yes, but before I'll do that I'd like to see the Consulor
laying my passport on his back, as she looks up puzzled,
she has to disprove my American citizenship." She
plies and taking my passport goes into the other side
office where she lays the passport on a counter. says
"there is no one could outside, who says adams to disprove his
U.S. citizenship." On "I am your says," thanks" he says to the
girl without looking up & now is typing. She, as she comes
out, invites me into the outer office to sit down. Said
so, selecting an armchair in the front left side of
Snyder's office it was; so when I talked to her
I wait, crossing my legs and laying my hands in my lap.
He finishes typing. handed the letter from his wife
and presenting his wife's reply: as I am.

"WHAT CAN I DO FOR YOU SO NICE" SAYING THOUGH MY MOUTH
"DO SEE TO EDUCATE MY YOUNG CITIZENSHIP AND WOULD LIKE
TO SEE THE SUGGESTION WITH THAT OBJECT. WE DON'T YOU APPRECIATE
FOR HAVING A CITIZENSHIP? YES. HE TAKING OUT A PIECE OF PAPER
AND SAYS "BEFORE WE GET TO THAT LET ME SEE SOME DEMAND LETTER
OR ANYTHING, PERSONAL INFORMATION TO WHICH I ANSWER THEM;
"YOUR MEMBERSHIP NOT COMING IN. FOR I HAVE BEEN ASSOCIATED WITH INDIA
2000. HAVING A WIFE AMERICAN CITIZENESS LIMA, I HAVE
WORKED, AND I WORKED TWO YEARS FOR THAT. I DON'T WANT TO LIVE
IN THE U.S. OR BE DESTITUTE OF AMERICAN CITIZENSHIP. HE SAID
OK. THAT'S ALL WE CAN DO YOU WANT TO PRACTICE YOUR TRADE IN INDIA
YOU CAN, CO. I SAID "I'D REQUEST YOU THAT I BE ALLOWED TO GIVE LEGAL
PAPERS. DEMANDING RIGHT OF CITIZENSHIP; YOU REFUSED AT THAT TIME.
HE SAID "NOT AT THAT TIME, BUT THE OTHER WILL TAKE SOME TIME TO GET BACK
INTO THE POSITION WHERE ONE CAN PRACTICE. DURING "ABOUT 2-3 MONTHS"
IT STOLE MY HOME AT ECRU, KOLKATA. I HAD TO LEAVE INDIA AND
I DON'T KNOW SINCE THEN WHERE I AM.
