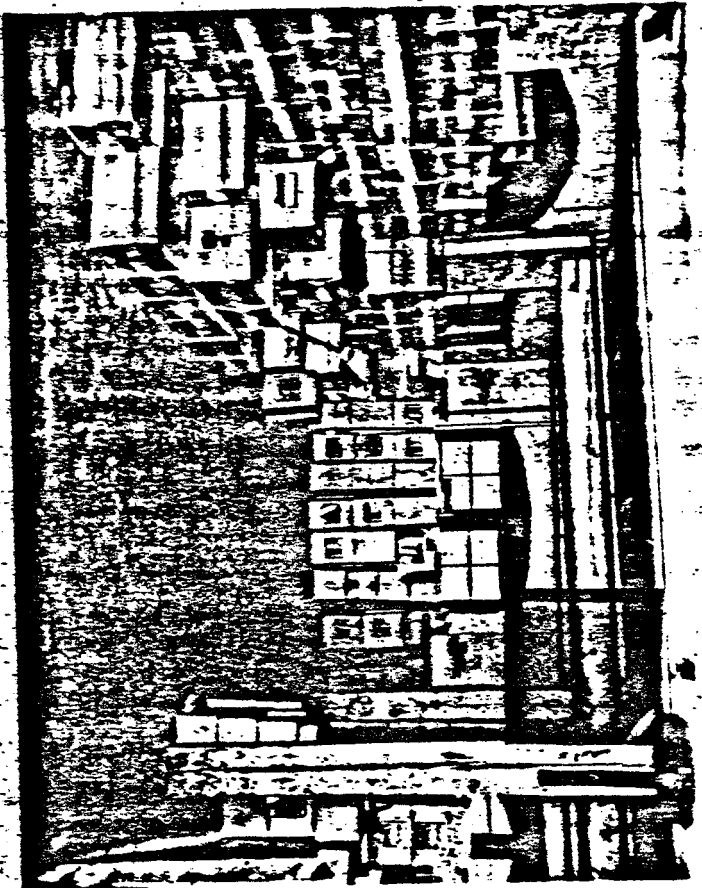








View looking east on 6th floor, Texas
