for reinterview. On interview by Bureau Agents, Lima stated he was not certain it was Oswald he saw talking to Cubans. His statements concerning length of stay at hotel differ substantially from hotel records and from info furnished by one of the Cubans from hotel records and from info furnished by one of the Cubans Huerta Oliva who was interviewed by MM. Necessary to run out all aspects to evaluate Lima's veracity and to determine if, in fact, Oswald did associate with Cubans at hotel.
