NEW ORLEANS--THE ORLEANS PARISH (COUNTY) GRAND JURY TODAY RESUMED  
 ITS INVESTIGATION OF AN ALLEGED CONSPIRACY TO ASSASSINATE PRESIDENT  
 KENNEDY, BUT COULD NOT LOCATE A LOUNGE OWNER IT WANTED TO QUESTION.  
 IN ANOTHER DEVELOPMENT, JUDGE FRANK SHEA PREPARED TO ARRAIGN FORMER  
 JEFFERSON PARISH DIST. ATTY. DEAN ANDREWS JR. ON A PERJURY INDICTMENT,  
 BELIEVED TO HAVE RESULTED FROM GRAND JURY TESTIMONY.  
 SHERIFF LOUIS HEYD JR. SAID HIS MEN LAST NIGHT ATTEMPTED TO  
 SUBPOENA GORDAN NOVELL AT NOVELL'S JAMAICAN VILLAGE LOUNGE. BUT  
 DEPUTIES WERE TOLD THAT NOVELL SOLD THE LOUNGE SUNDAY AND LEFT NO  
 FORWARDING ADDRESS.  
 NOVELL'S ATTORNEY, STEVE POLTKIN SAID HE WOULD SEE TO IT THAT  
 HIS CLIENT APPEARED.  
 NOVELL SHOWED UP FOR THE GRAND JURY LAST THURSDAY BUT WAS NEVER  
 CALLED IN TO THE ROOM AND REPORTEDLY WAS REQUESTED TO RETURN TODAY.
