(KENNEDY ASSASSINATION)

NEW ORLEANS--DIST. ATTY. JIM GARRISON REPORTEDLY WILL ASK THE U.S. SENATE THIS WEEK TO INVESTIGATE AN ALLEGED CENTRAL INTELLIGENCE AGENCY "COVERUP" IN CONNECTION WITH THE WARREN COMMISSION PROBE OF THE KENNEDY ASSASSINATION.

THE NEW ORLEANS STATES-ITEM QUOTED GARRISON AS SAYING THE CIA AND THE FBI COOPERATED IN CONCEALING FACTS FROM THE COMMISSION.

THE STORY DID NOT SAY HOW GARRISON WOULD SEEK SENATE AID, BUT HE IS A KNOWN POLITICAL AND PERSONAL FRIEND OF SENATE MAJORITY WHIP RUSSELL LONG. LONG HAS GIVEN ENCOURAGEMENT TO GARRISON'S ASSASSINATION INVESTIGATION AND HAS EXPRESSED DOUBTS ABOUT THE WARREN COMMISSION REPORT.

GARRISON CHARGED SATURDAY THAT THE CIA GAVE THE WARREN COMMISSION A FAKE PHOTOGRAPH INSTEAD OF PROVIDING A PICTURE OF LEE HARVEY OSWALD AND A CUBAN COMPANION LEAVING THE CUBAN EMBASSY IN MEXICO CITY IN 1963.

GARRISON SAID THE REASON FOR THE FAKE PHOTOGRAPH WAS THAT OSWALD AND/OR HIS CUBAN COMPANION WERE CIA AGENTS.

HE CONFIRMED TODAY THAT HIS INVESTIGATION OF THE ASSASSINATION IS AIMED AT SHOWING THAT OSWALD, THE ACCUSED ASSASSIN, WAS WORKING AS A CIA AGENT HERE IN 1963 WHILE OUTWARDLY DISTRIBUTING LEAFLETS FOR CASTRO'S COMMUNIST GOVERNMENT.

"OSWALD'S FAIR PLAY FOR CUBA ACTIONS IN NEW ORLEANS CONSTITUTED A TRANSPARENT SHAM," THE DISTRICT ATTORNEY WAS QUOTED AS SAYING.

THE DISTRICT ATTORNEY SAID OSWALD WAS IN CONSTANT ASSOCIATION WITH ANTI-CASTRO GROUPS AND FEDERAL AGENTS WERE AWARE OF IT.
