(KENNEDY ASSASSINATION)

NEW ORLEANS--A CUBAN EXILE LEADER WHO ONCE SCUFFLED WITH LEE HARVEY OSWALD EXPRESSED INDIGNATION TODAY AT DIST ATTY. JIM GARRISON'S ATTEMPTS TO LINK OSWALD WITH ANTI-CASTRO ORGANIZATIONS. "IT IS RIDICULOUS," SAID DR. CARLOS BRINGUIER, NEW ORLEANS DELEGATE TO THE CUBAN STUDENT DIRECTORATE. GARRISON, WHO IS UNDER A COURT ORDER NOT TO DISCUSS THE ASSASSINATION CONSPIRACY TRIAL OF NEW ORLEANS BUSINESSMAN CLAY L. SHAW, HAS TOLD THE NEW ORLEANS STATES-ITEM IN RECENT DAYS THAT: --OSWALD WAS PROBABLY A CIA AGENT WHO WORKED UNDERCOVER WITH ANTI-CASTRO CUBANS WHILE PUBLICLY DEMONSTRATING FOR CAIRO. --THE CENTRAL INTELLIGENCE AGENCY (CIA) AND THE FBI WERE AWARE OF OSWALD'S ALLEGED CONNECTIONS WITH ANTI-CASTRO ORGANIZATIONS, BUT WITHHELD THE INFORMATION FROM THE WARREN COMMISSION. --THE CIA AND THE FBI PRESENTED THE COMMISSION A FAKE PICTURE OF OSWALD AND WITHHELD INFORMATION ABOUT OSWALD BECAUSE HE AND/OR A CUBAN COMPANION WERE CIA AGENTS. --THE DISTRICT ATTORNEY PLANS TO SEEK A SENATE INVESTIGATION OF WHAT HE SAYS IS A CIA "COVERUP," POSSIBLY WITH THE HELP OF SEN. RUSSELL B. LONG, GARRISON'S PERSONAL FRIEND AND SUPPORTER. THE CIA, THE JUSTICE DEPARTMENT, LONG AND THE FBI ALL DECLINED TO COMMENT ON THE GARRISON STATEMENTS. DIST. JUDGE EDWARD A. HAGGERTY JR., WHO WILL HANDLE SHAW'S ASSASSINATION CONSPIRACY TRIAL, DECLINED TO COMMENT ON WHETHER GARRISON HAD VIOLATED THE COURT'S GUIDELINES.

 --THE CENTRAL INTELLIGENCE AGENCY (CIA) HAS BEEN ADVISED
 AWARE OF OSWALD'S ALLEGED CONNECTIONS WITH ANTI-CASTRO
 ORGANIZATIONS, BUT WITHHOLD THE INFORMATION FROM THE SENATE
 COMMITTEE.
 --THE CIA AND THE FBI WERE GIVEN THE CONSPIRACY A YEAR
 BEFORE OSWALD AND WITH THE FBI'S AID IN NEW ORLEANS TO
 MAKE A SEARCH FOR OSWALD'S CIA TIES.
 --THE DISTRICT ATTORNEY PLANS TO START A SENATE INVESTIGATION
 OF WHAT HE SAYS IS A CIA "CONSPIRACY" TO ASSASSINATE SENATOR
 RUSSELL L. LONG, MISSISSIPPI'S SENATOR, WHOSE SENATE TRIAL
 THE CIA, THE JUSTICE DEPARTMENT, LONG AND THE FBI ALL DECLINED
 TO COMMENT ON THE JEFFERSON STATEMENTS. DIST. JUDGE EDWARD A.
 HAGGERTY JR. WHO WILL HANDLE OSWALD'S ASSASSINATION CONSPIRACY
 TRIAL, DECLINED TO COMMENT ON OSWALD'S CONSPIRACY AND VIOLATED THE
