DANN 5/26 HX.  
 DETROIT (UPI)--A LAWYER FOR THE LATE JACK RUBY, CONVICTED  
 KILLER OF PRESIDENT KENNEDY'S ASSASSIN, FRIDAY CALLED FOR THE  
 DISBARMENT OF NEW ORLEANS DIST. ATTY. JIM GARRISON.  
 SOL DANN FORMALLY PETITIONED THE AMERICAN BAR ASSOCIATION IN  
 CHICAGO AND THE LOUISIANA STATE BAR ASSOCIATION IN BATON ROUGE  
 TO INVESTIGATE GARRISON'S PROBE OF THE KENNEDY ASSASSINATION "PLOT."  
 DANN ASKED THE ASSOCIATIONS TO "INVESTIGATE AND INTERVENE IN ALL  
 PROCEEDINGS CONCERNING THE ASSASSINATION OF PRESIDENT JOHN F.  
 KENNEDY AND THE UNWARRANTED OR RECKLESS ATTACKS ON THE INTEGRITY OF  
 THE WARREN COMMISSION REPORT...ESPECIALLY THOSE CONNECTED WITH OR  
 CONDUCTED BY DIST. ATTY. JIM GARRISON IN NEW ORLEANS."  
 DANN, A FREQUENT CRITIC OF THE GARRISON INVESTIGATION, SAID THE  
 ASSOCIATIONS SHOULD DETERMINE THE NEED FOR "DISBARMENT OR OTHER  
 APPROPRIATE DISCIPLINARY PROCEEDINGS" AGAINST GARRISON OR ANY OTHER  
 MEMBER OF THE BAR INVOLVED IN THE CASE, EITHER AS AN INVESTIGATOR OR  
 AN AUTHOR.  
 "THIS REQUEST IS MADE TO PUT AN END TO ANY FURTHER EXPLOITATION OF  
 THIS HORRIBLE TRAGEDY...AND TO PREVENT ANY MISCARRIAGE OF JUSTICE  
 THAT IS SUBJECTING THE JUDICIARY AND LEGAL PROFESSIONS TO RIDICULE,  
 CRITICISM AND DISREPUTE," DANN SAID.
