(KENNEDY ASSASSINATION)

NEW ORLEANS--CRIMINAL DISTRICT JUDGE EDWARD HAGGERTY JR., WHO IS TO PRESIDE AT THE TRIAL OF CONSPIRACY DEFENDANT CLAY SHAW IN THE KENNEDY ASSASSINATION INVESTIGATION, WILL ISEE A NEW SET OF GUIDE LINES MONDAY.

THE LAST TIME JUDGE HAGGERTY ISSUED SUCH RULES, HE PROHIBITED ANYONE CONNECTED WITH THE CASE IN AN OFFICIAL CAPACITY TO COMMENT ON IT.

THERE WAS CONSIDERABLE CRITICISM LEVELED AT THE PROSECUTION'S APPROACH TO THE FIRST SET OF GUIDELINES.

STILL AT LARGE IN THE CASE IS GORDON NOVEL, THE MAN DIST. ATTY. JIM GARRISON SEEKS AS A MATERIAL WITNESS.

DALLAS--DIST. ATTY. HENRY WADE SAID YESTERDAY HE DID NOT BELIEVE A NEW ORLEANS INVESTIGATION INTO PRESIDENT KENNEDY'S ASSASSINATION WOULD PROVE THAT SOMEONE OTHER THAN LEE HARVEY OSWALD FIRED THE FATAL BULLET.

"I THINK EVERYBODY WHO KNOWS WHAT THE EVIDENCE IS BELIEVES OSWALD FIRED THE SHOTS FROM THE BUILDING (THE TEXAS SCHOOLBOOK DEPOSITORY)," WADE SAID.

THE DISTRICT ATTORNEY ALSO SAID THE RELEASE OF FILM BY UPI SHOWING WHAT MANY PERSONS THOUGHT WAS A MAN WITH A GUN NEAR THE ASSASSINATION SITE WAS ONLY SHADOWS WOULD HAVE ANY QUIETING EFFECT ON CRITICS OF THE WARREN COMMISSION.

"YOU WILL STILL HAVE PEOPLE TRYING TO SELL SOME BOOKS," HE SAID.
