CHICAGO (UPI) -- POLITICAL ACTIVIST DICK GREGORY SAYS HE HAS EVIDENCE "OF VALUE" CONCERNING THE ASSASINATIONS OF PRESIDENT JOHN F. KENNEDY AND HIS BROTHER, ROBERT.

GREGORY FLEW TO WASHINGTON THURSDAY TO DELIVER DOCUMENTS TO THE ROCKEFELLER COMMISSION INVESTIGATING THE CIA.

"I HAVE IN MY POSSESSION EVIDENCE OF VALUE TO A THOROUGH INVESTIGATION ... " GREGORY TOLD A CHICAGO NEWS CONFERENCE EARLIER THURSDAY. "I HAVE EVIDENCE WHICH PLACES SOME OF THE SAME FAMILIAR PERSONS IN THE WATERGATE SCANDAL IN DALLAS AT THE TIME OF PRESIDENT KENNEDY'S ASSASSINATION. I ALSO HAVE EVIDENCE WHICH RAISES SERIOUS QUESTIONS ABOUT SIRHAN SIRHAN'S ROLE AS THE LONE ASSASSIN OF SENATOR (ROBERT) KENNEDY."

GREGORY AND RALPH SCHOENMAN, AN AUTHOR AND TEACHER, RELEASED BLOWN UP PHOTOGRAPHS OF VAGRANTS IN POLICE CUSTODY IN DALLAS AT THE TIME OF THE PRESIDENT'S DEATH. THE TWO MEN APPEAR TO RESEMBLE CONVICTED WATERGATE CONSPIRATORS E. HOWARD HUNT AND FRANK STURGIS, THEY SAID. HUNT, A FORMER CIA AGENT, AND STURGIS WERE BOTH SENT TO PRISON FOR THEIR PART IN THE WATERGATE CASE.

THE MEN ALSO RELEASED A COPY OF THE REPORT ON THE AUTOPSY OF ROBERT F. KENNEDY BY DR. THOMAS NOGUISHI, CHIEF MEDICAL EXAMINER-CORONER OF LOS ANGELES COUNTY. THE REPORT, THEY SAID, SHOWED THAT THE BULLET WHICH KILLED KENNEDY WAS FIRED INTO THE BACK OF KENNEDY'S HEAD AT CLOSE RANGE WHEREAS SIRHAN WAS SOME DISTANCE AWAY. PRESSED BY REPORTERS ON THE EXTENT OF THEIR ALLEGATIONS, SCHOENMAN SAID, "I THINK ROBERT KENNEDY AND JOHN KENNEDY WERE MURDERED BY PEOPLE ASSOCIATED WITH THE UNITED STATES GOVERNMENT AND ITS INTELLIGENCE AGENCIES."
