MADISON, WIS. (UPI) -- MICHAEL F. BROZEK, PRESIDENT OF THE WISCONSIN YOUNG DEMOCRATS, SAYS THERE'S NO DOUBT IN HIS MIND THAT A CONSPIRACY WAS RESPONSIBLE FOR THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY.

HE SAID HE HAS SPENT THE BETTER PART OF TWO YEARS TRYING TO GET CONGRESS TO REOPEN THE INVESTIGATION.

BROZEK, 22, A RESEARCH ANALYST FOR WISCONSIN ATTORNEY GENERAL ERONSON LA FOLLETTE, HAS ACCESS TO A COPY OF THE ABRAHAM ZAPRUDEK MOVIE FILM OF THE EXACT MOVEMENTS OF KENNEDY'S FATAL SHOOTING IN DALLAS, TEX., NOV. 22, 1963.

HE BELIEVES IT SHOWS CONCLUSIVELY THAT KENNEDY WAS HIT BY TWO ASSASSINS, NOT ONE, AS THE WARREN COMMISSION CONCLUDED. HE SHOWED THE FILM IN THE STATE CAPITOL TUESDAY.

"IT IS FASHIONABLE NOW TO BELIEVE THE CONSPIRACY THEORY," BROZEK SAID. "BUT AT TIMES MY SANITY WAS QUESTIONED BY PEOPLE WHO SAID THAT COULD NOT HAPPEN IN AMERICA."

"I NEVER FULLY BELIEVED LEE HARVEY OSWALD DID THE SHOOTING HIMSELF," HE SAID. "I SHOT A RIFLE EXACTLY LIKE OSWALD'S--AN ITALIAN 6.5 CARCANO. THE ITALIANS CALLED IT THE 'HUMANITARY RIFLE' BECAUSE YOU COULDN'T HURT ANYONE ON PURPOSE WITH IT, IT WAS SO INACCURATE."

HE SAID HE TRAVELED TO THE DALLAS ASSASSINATION SITE THREE TIMES, TOOK MEASUREMENTS, TALKED TO THE OFFICER WHO ESCORTED OSWALD WHEN HE WAS SHOT BY JACK RUBY AND STUDIED ALL THE MATERIAL HE COULD GATHER.

"I BELIEVE THE ASSASSINATION WAS A WELL-PLANNED CONSPIRACY AND ALTHOUGH I AM IN NO POSITION TO PLACE BLAME, I HAVE THEORIES WHO WAS BEHIND IT," BROZEK SAID.

HE SAID HE BELIEVED THE CONSPIRATORS WERE "HOT-HEADS, REACTIONARIES" IN SOME GOVERNMENT AGENCIES, RIGHT-WING BUSINESS LEADERS AND THE MAFIA.

EROZEK SHOWED NEWS PICTURES HE SAID SHOWED THAT CENTRAL INTELLIGENCE AGENCY AGENTS WERE AT THE SCENE SHORTLY AFTER THE ASSASSINATION.

HE SAID THE MAFIA COULD HAVE BEEN INVOLVED BECAUSE ROBERT F. KENNEDY "WAS PROSECUTING MORE MAFIA CHARACTERS THAN ANY ATTORNEY GENERAL IN HISTORY." HE CITED A POSSIBLE CUBAN LINK WITH THE CIA BECAUSE PRESIDENT KENNEDY REFUSED TO SUPPLY AIR SUPPORT DURING THE BAY OF PIGS INVASION.

EROZEK THEORIZED THE WARREN COMMISSION DID NOT REVEAL THE ALLEGED CONSPIRACY BECAUSE "IT FEARED A TOTAL UNDERMINING OF THE U.S. GOVERNMENT IF THE AMERICAN PEOPLE WERE TO FIND OUT. AMERICA, THEY THOUGHT, WOULD END UP IN CHAOS." DUPLICATE TO B WIRE POINTS
