The Crackpot Theories

Not long ago I commented on one of the worst aspects of what might be called Watergate fallout: a spate of fresh leftwing crackpot theories concerning the assassinations of President John Kennedy and Sen. Robert Kennedy.

Since that column, several new amateur assassination experts have come forward with such theories, including former comedian Dick Gregory who says that the same gun that killed Martin Luther King was used to kill Robert Kennedy two months later.

Gregory is the second ex-comic to go into the field of historical revision. Mort Sahl was the first. Which is what happened?
