MUSTIN, TEX. (UPI) -- FORMER TEXAS ATTORNEY GENERAL WAGGONER CARR SAYS A NEW INVESTIGATION SHOULD BE LAUNCHED INTO THE RECORDS OF THE FBI AND THE CIA IN THE ASSASSINATION OF PRESIDENT JOHN KENNEDY TO STOP ANY ALLEGATIONS OF A COVER-UP.

CARR, WHO HEADED THE TEXAS INQUIRY INTO THE ASSASSINATION, SAID MONDAY THE WARREN COMMISSION WAS TOO DEPENDENT ON INVESTIGATIONS CONDUCTED BY THE TWO INTELLIGENCE AGENCIES THEMSELVES.

CARR SAID THE SENATE INTELLIGENCE COMMITTEE SHOULD CONDUCT A NEW INVESTIGATION TO DETERMINE IF LEE HARVEY OSWALD WAS CONNECTED WITH THE CIA AND FBI AND IF THE AGENCIES OR THE SECRET SERVICE HAD ADVANCE INFORMATION OSWALD WAS A THREAT TO THE PRESIDENT BUT FAILED TO ACT ON IT.

CARR SAID HIS DISSATISFACTION WITH THE WARREN COMMISSION REPORT IS LIMITED TO THE BELIEF IT PLACED ON FBI AND CIA CHIEFS TO DISCLOSE THEIR OWN FAILINGS.

"DO NOT LET US GET INTO THINKING THE PEOPLE OF THIS COUNTRY ARE GOING TO BELIEVE THE RESULT OF A FEDERAL AGENCY'S INVESTIGATION OF ITSELF," CARR SAID.

IN A LETTER TO SEN. JOHN TOWER, R-TX., AND LLOYD BENTSEN, D-TEX., CARR SAID:

"I ASSURE YOU THAT I HAVE NO DESIRE TO HARM OR DAMAGE THE PROPER IMAGE OF THE FBI, CIA OR SECRET SERVICE, BUT, RATHER, I DESIRE TO MAKE IT ACCOUNTABLE TO THE AMERICAN PEOPLE FOR ITS FAILURE, IF ANY, AS WELL AS TO RECEIVE THE PRAISES OF THE AMERICAN PEOPLE FOR ITS ACCOMPLISHMENTS."

"THIS CANNOT BE ATTAINED BY COVER-UPS OR MISLEADING PUBLIC STATEMENTS."

LEG. JAWORSKI, FORMER SPECIAL WATERGATE PROSECUTOR WHO ASSISTED CARR IN THE TEXAS INVESTIGATION, SAID HE SAW NO NEED TO REOPEN THE CASE.

"I DON'T WANT TO GET INTO ANY CROSSFIRE WITH HIM, BUT I PERSONALLY STAND BY THE CONCLUSIONS OF THE WARREN COMMISSION REPORT AND OUR OWN TEXAS SUPPLEMENTAL REPORT," JAWORSKI SAID.

"THERE IS NOTHING IN THERE TO SUGGEST THAT A CONSPIRACY NOT RECORDED ASSASSINATE THE PRESIDENT EXISTED."

CARR SAID THE WARREN COMMISSION IGNORED HIS REQUEST IN 1963 THAT EVERY CIA AND FBI AGENT IN DALLAS TO BE QUESTIONED INDIVIDUALLY.

"THE COMMISSION DETERMINED THAT IT WOULD RELY ALMOST ENTIRELY UPON THE STORN TESTIMONY OF THE HEAD OF THE FBI, ST. J. EDGAR HOOVER, AND THE CIA, MR. (JOHN) EDGEE AND MR. (RICHARD) HELMS, AS TO THE INVESTIGATION THEY THEMSELVES HAD CONDUCTED WITHIN THEIR OWN AGENCIES ON THIS QUESTION," CARR SAID.
