ADAN'S SAID EMPLOYES OF THE DALLAS FEI BUREAU CONFIRMED EARLIER REFORTS THE FRIET NOTE TO THE AGENT, WHO HAD EEEN INVESTIGATING ALLEGED SUPVERSIVE ACTIVITIES BY OSWALD, HAD NOTHING TO DO WITH THE KENNEDY NURDER. OUOTING A SECRETARY AT THE FFI, ADAMS TESTIFIED THE NOTE SAID: "ILT THIS EE A WARNING. I WILL ELOW UP THE FFI AND THE DALLAS FOLICE DEPARTMENT IF YOU DON'T STOP BOTHERING MY WIFE." OTHERS INVTERVIEWED SUPFORTED THE SECRETARY, ADAMS SAID. IN THE PREPARED TESTIFONY, ADAMS DENIED ONE PUELISHED REPORT THAT RUEY WAS A PAID FEI INFORMANT.
