30 From Oct. 16 1959 arrival - evening

1ST MEETING

OCT. 16. ARRIVE FROM HELSINKI BY TRAIN; AM MET BY INTEGREST REP. AND IN CAR, TO HOTEL "BERLIN". REFERRED AS "STOOGT" S LAY (LUX TOURIST TICKET,) MEET MY INTRODUCED RIMMA SHERIKOVA. I EXPLAIN TO HER I WISH TO APPLY FOR RUSS. CITIZENSHIP. SHE IS HOBNOBBLED BUT AGREES TO HELP. SHE CHECKS WITH HER BOSS, MAIN OFFICE IN UHURU; THAN HELPS ME ADD LETTER TO SUP. COURT. ASKING FOR CITIZENSHIP. MEANWHILE BOSS TELEPHONES PASSPORT & VISA OFFICE AND NOTIFIES THEM ABOUT ME.

OCT. 17. RIMMA MEETS ME FOR INTRODUCED SIGHTSEEING AND WE HEAR CONVERSATION WITH THIS WOMAN I AM TOO NERVOUS SHE IS "FYLIE" SHE HAD AN ANSWER. SOON ASKS ME ABOUT MYSELF AND ASK REASONS FOR DOING THIS. I EXPLAIN I AM A COMMUNIST, ETC. SHE IS HOLLY SYM. BUT UNHAPPY NOW. SHE WANTS TO BECOME FRIEND TO ME. SHE FEELS SORRY FOR ME I AM SOMETH. NEVER.

SUNDAY OCT. 18. MY 20TH BIRTHDAY, WE VISIT EXHIB. IN MORNING AND IN THE AFTERNOON THE LENIN-STALIN TOMB. SHE GIVES ME A PRESENT BOOK "IDEAS" BY DOSTOEVSKY.

OCT. 19. TOURISM. AM ANXIOUS SINCE MY VISA IS GOOD FOR FIVE DAYS ONLY AND STILL REQUIRED FROM AUTH. ABOUT MY REQUEST.

OCT. 20. RIMMA IN THE AFTERNOON SAYS INTEGREST WAS NOTIFIED BY THE PASSPORT OFFIC. THAT THEY WANT TO SEE ME. I AM EXCITED GREATLY BY THIS NEWS.

OCT. 21. MEETING WITH STATE OFFICIAL. BALDING STOOGT, BLACK SUIT, DARK HAIR. GOOD ENGLISH, ASKS WHAT DO I WANT, I SAY SOVIET CITIZENSHIP. HE ASK WHY & GIVE VALUABLE ANSWERS ABOUT "GREAT SOVIET UNION". HE TELLS ME "USSR ONLY GREAT IN LITERATURE" WANTS ME TO GO BACK HOME. I AM SHOCKED & REITERATE. HE SAYS HE SHALL CHECK AND LET ME KNOW WHETHER MY VISA WILL BE EXTENDED IT EXPIRES TODAY.

EVE. 6:00 REVIEW WORD FROM POLICE OFFICIAL. I MUST LEAVE COUNTRY TONIGHT AT 8:00 PM AS VISA EXPIRES. I AM SHOCKED!! MY DREAMS! I RETIRE TO MY ROOM. I HAVE \$100. LEFT. I HAVE WAITED FOR 2 YEAR TO BE ACCEPTED. MY FOND DREAMS ARE SHATTERED BECAUSE OF A PETTY OFFICIAL BECAUSE OF BAD PLANNING I PLANNED SO MUCH! 7:00 AM, I DECIDE TO END IT. SOAK RIBS IN COLD WATER TO NUMB THE PAIN, THAN SLASH MY LEFT WRIST. THEN PLACE WRIST INTO BATH TUB OF HOT WATER. I THINK WHEN RIMMA COMES AT 8:00 TO FIND ME DEAD IT WILL BE A GREAT SHOCK. SOMEWHERE, A VIOLIN PLAYS, AS I

OCT. 21. (cont.) WITH MY LIFE WHICH AWAY, I THINK TO MYSELF, "IT'S EASY TO DIE" AND "A SWEET DEATH, (TO VIOLENTS) ABOUT 200 RUSSIANS FINDS ME UNCONSCIOUS CARDBOARD. WATER AND RED COLOR. SHE SCREAMS (I REMEMBER THAT) AND RUNS FOR HELP. AMBULANCE COMES, AM TAKEN TO HOSPITAL. RUSSIAN FRIENDS, NOT FINE IN MY WRIST. POOR RIMMA STAYS BY MY SIDE AS INTERPRETER. MY RUSSIAN IS STILL VERY BAD. FAR ED INTO THE NIGHT, I TELL HER TO HOME (MY MOOD IS BAD) BUT SHE STAYS, SHE IS MY FRIEND. SHE HAS A STICKIE WITH ONLY AT THIS MOMENT I NOTICE SHE IS PRETTY.

OCT. 22. MORN. I AM IN A SMALL ROOM WITH ABOUT 12 OTHERS (ICK PERSONS,) 2 GUARDIANS AND A NURSE. THE ROOM IS VERY DRAFTY AS WELL AS THE BREAKFAST. ONLY AFTER ALARMED (2 HOURS) OBSERVATION OF THE OTHER PAT. OF POLICE I AM IN THE DISMISSED WARD. THIS REGISTRATION DISGOWTS ME. LATER IN AFTERNOON I AM VISITED BY RIMMA, SHE COMES IN WITH TWO DOCTORS AS ENTREPRENEURS. SHE MOST ASK ME MEDICAL QUESTIONS: DID YOU KNOW WHAT YOU WERE DOING? ANSWERS YES. DID YOU BLACK OUT? NO. ETC. I TALK COMPLY ABOUT POOR FOOD THE DOCTORS LAUGH APP. THIS IS A GOOD SIGN. LATER THEY LEAVE, I AM ALONE WITH RIMMA (AMONGST THE MENTAL) (11) SHE ENCOURAGES ME AND SCILLS ME. SHE SAYS SHE WILL HELP ME GET TRANSFERRED TO ANOTHER SECTION OF HOS. (NOT FOR INSANE) WHERE FOOD IS GOOD.


OCT. 23. TRANSFERRED TO ORDINARY WARD, (AIRY, GOOD FOOD.) BUT NURSES SUSPICIOUS OF ME. (THEY KNOW) AFTERNOON I AM VISITED BY ROSA ABRAFOMOVNA OF THE HOTEL, WHO ASKS ABOUT MY HEALTH, VERY BEAUTIFUL, EXCELLENT ENG., "VERY HUMBLE AND KIND," SHE MAKES ME VERY GLAD TO BE ALIVE. LATER RIMMA VISITS.

OCT. 24 /HOSPITAL ROUTINE, RIMMA VISITS ME IN AFTERNOON

OCT. 25. / "

OCT. 26 AN ELDERLY AMERICAN AT THE HOSPITAL GROW SUSPICIOUS ABOUT ME FOR SOME REASON. PROBABLY BECAUSE AT DINNER I TOLD HIM I HAD NOT REGISTERED AS A TOURIST AND I AM IN GENERAL EVASIVE ABOUT MY PRESENCE IN MOSCOW AND AT HOSPITAL. RIMMA VISITS. OCT. 27. STICKIES ARE TAKEN OUT BY DOCTOR WITH DULL SCISSOR.

OCT. 28 /I LEAVE HOSPITAL IN INTEREST CITY. WITH RIMMA FOR HOTEL "BERLIN" LATER I CHANGE HOTELS TO "METROPOLE", ALL CLOTHES PACKED AND MONEY FROM MY ROOM (TO THE LAST KOPEEK) RETURNED AS WELL AS WATCH, RIMMA LUDMILA CHMIRKOVA (INTEREST OFFICE HEAD). MR. ROSA INVITE ME TO COME AND SEE AND TAKE WITH THEM ANY TIME. I GET LONGSOME AT NEW HOTEL. THEY FEEL SORRY FOR ME.



OCT. 28 (Cont) RIMMA notifies me that, PASS REGISTRATION OFFICE wishes to see me about my future. LATER RIMMA AND CAR PICK ME UP AND WE ENTER THE OFFICES TO FIND FOUR OFFICIALS WAITING FOR ME (ALL UNKNOWN TO ME). THEY ASK HOW MY ARM IS, I SAY OK. THEY ASK "DO YOU WANT TO GO TO YOUR HOMELAND." I SAY NO I WOULD SOONER CITIZEN TO GO TO YOUR HOME LAND. THEY SAY I WANT TO RESIDE IN THE SOVIET UNION. THEY SAY THEY WILL SEE ABOUT THAT. THEN THEY ASK ME ABOUT THE ONE OFFICIAL WITH WHOM I SPOKE IN THE FIRST PLACE (HE). HE DID NOT PASS ALONG MY REQUEST AT ALL BUT THOUGHT TO SIMPLY GET RID OF ME BY NOT EXTERDING MY SOVIET VISA. AT THE TIME I REQUESTED IT, I DESCRIBE HIM. THEY MAKE NOTES (WHAT PLACES DO YOU HAVE TO SHOW WHO AND WHAT YOU ARE?) I GIVE THEM MY DISCHARGE PAPERS FROM THE MARINE CORPS. THEY SAY WAIT FOR OUR ANSWER. I ASK HOW LONG? NOT SOONER. LATER RIMMA COMES TO CHECK ON ME. I FEEL ENTHUSED AND EXCITED. OCT. 29 HOTEL ROOM 214 METROPOLIS HOTEL. I WAIT. FLUCKY I EAT once, STAY NEAR TO PHONE WORK. I SLEEP FULLY DRESSED OCT. 30 HOTEL ROOM. I HAVE BEEN IN HOTEL THREE DAYS, IT SEEMS LIKE THREE YEARS. I MUST HAVE SOME SECRET OF A SHOWDOWN.

OCT. 31. I MAKE MY DECISION. GETTING DRESSING AT 12:00 I MEET AND TALK WITH RIMMA FOR A FEW MINUTES. SHE SAYS: "STAY IN YOUR ROOM AND EAT WELL, I DON'T TELL HER ABOUT WHAT I INTEND TO DO SINCE I KNOW SHE WOULD NOT APPROVE. AFTER SHE LEAVES I WAIT A FEW MINUTES AND THEN I CATCH A TAXI "AMERICAN EMBASSY" I SAY. 12:30, I ARRIVE AMERICAN EMBASSY, I WALK IN AND SAY TO THE RECEPTIONIST "I WOULD LIKE TO SEE THE CONSULAR". SHE POINTS AT A LADY LATER AND SAYS "IF YOU ARE A TOURIST PLEASE REGISTER". I TAKE OUT MY AMERICAN PASSPORT AND SAY IT IN THE DESK, I HAVE COME TO DISSENGAGE MY AMERICAN CITIZENSHIP. I SAY MOTHER-OF-FOOTED AND SHE TELLS ME AND ENTERS THE OFFICE OF RICHARD SNYDER OR LUCILLE REED CONSUL IN MOSCOW. AT THAT TIME HE INVITES ME TO SIT DOWN. HE FINISHES A LETTER HE IS TYPING AND THEN ASKS WHAT HE CAN DO FOR ME. I TELL HIM I HAVE DECIDED TO TAKE SOVIET CITIZENSHIP AND WOULD LIKE TO LEGALLY DISSENGAGE MY U.S. CITIZENSHIP. HIS ASSISTANT KNOWS REED CONFERRED WITH VICKERS LOOKS UP FROM HIS WORK SAYING OTHERS DOWN. PERSONNEL INFORMATION, EACH QUESTION


SAT OUT 31. CAV warned me not to take any steps before the Soviets except me; says I am a "fool", and says the dissolution papers are along time in preparing. In other words refuses to allow me at that time to dissolve U.S. CITIZ. I STATE "MY MIND IS MADE UP" FROM THIS DAY FORWARD. I CONSIDER MYSELF NO CITIZEN OF THE U.S.A. I SPENT 40 MINUTES AT THE EMBASSY BEFORE INYET SAYS "NOW UNLESS YOU WISH TO EXPOSE ON YOUR MARXIST BELIEFS YOU CAN GO." I WISH TO DISMISS HIS C.I.D., NOT TODAY HE SAYS IN EFFECT. I LEAVE EMBASSY ELATED AT THIS SHOWDOWN, RETURNING TO MY HOTEL. I FEEL NOW MY ENEMIES ARE NOT SPONTANEOUSLY VAIN. I AM SURE RUSSIANS WILL EXCUSE ME AFTER THIS SIGN OF MY FAITH IN THEM. 200 AM KNOCK. A REPORTER BY THE NAME OF GOKSTEN WANTS AN INTERVIEW. I'M FLACKERBAGGED & HOW DID YOU FIND OUT? THE EMBASSY CALLED US. HE said. I SENT HIM AWAY. I SAW AND REALIZE THIS IS ONE WAY TO BRING PRESSURE ON ME. BY NOTIFYING MY RELATIONS IN U.S. THROUGH THE NEWSPAPERS. ALTHOUGH THEY WOULD SAY "YES FOR THE PUBLIC RECORD". A HALF HOUR LATER ANOTHER REPORTER MRS MOSBY COMES. I ANSWER A FEW QUICK QUESTIONS AFTER REFUSING AN INTERVIEW. I AM SURPRISED AT THE INTEREST. I GET PHONE CALLS FROM "TIME" AT NIGHT & PHONE CALL FROM THE STATES I REFUSE ALL CALLS WITHOUT FINDING OUT WHO IT IS. I FEEL I'M OVEREXPOSED BECAUSE OF THE ATTENTION. 10:00 I RETIRE.

MON. 1 - MORE REPORTERS, 3 PHONE CALLS FROM BROTHER MOTHER. NOW I FEEL SLIGHTLY AXIMINATED, NOT SO LONGY.

NOV 2-15 DAYS OF UTER LONELINESS. I REFUSE ALL REPORTERS. PHONE CALLS I REMAIN IN MY ROOM, I AM RACKED WITH PSYCHOSIS.

NOV 15 - I DECIDE TO GIVE AN INTERVIEW. I HAVE MRS. MOSBY'S CARD SO I CALL HER. SHE DRIVES RIGHT OVER. I GIVE HER MY STORY, ALLOW PICTURES, LATER STORY IS DISTORTED, SENT WITHOUT MY PERMISSION, THAT IS; BEFORE I EVER GAVE HER OKED HER STORY. AGAIN I FEEL SLIGHTLY BETTER BECAUSE OF THE ATTENTION.

NOV. 16. A RUSSIAN OFFICIAL COMES TO MY ROOM ASKS HOW I AM. NOTIFIES ME I CAN REMAIN IN USSR TILL SOME SOLUTION IS FOUND WITH WHAT TO DO WITH ME. IT IS COMFORTING NEWS.





Dec 17 - Dec. 30 I HAVE DRAUGHT MYSELF TOO SOLE-TEACHING RUSSIAN LANG. BECAUSE I FORCER MYSELF TO STUDY RUSSIAN DAY & NIGHT IN MY ROOM AND READ AND MEMORIZE WORDS. NO NEED TO TAKE IN MY ROOM. SHE IS VERY NICE I FOUND OUT ONLY RECENTLY SHE IS MARRIED, HAS SMALL SON WHO WAS BORN Crippled, THAT IS WHY SHE IS SO STRANGELY TENDER AND CONCERNING.

JAN 1-4 NO CHANGE IN ROUTINE
JAN 5. I AM CALLED TO PASSPORT OFFICE AND FINALLY GIVEN A SOVIET DOCUMENT NOT THE SOVIET CITIZENSHIP AS I SO WANTED, ONLY A RESIDENCE DOCUMENT, NOT EVEN FOR FOREIGNERS BUT A PASSPORT CALLED "FOR THOSE WITHOUT CITIZENSHIP". I TELL HER I AM HAPPY. THE OFFICER SAYS THEY ARE SENDING ME TO THE CITY OF CHIRIKOV I ASK "IS THAT IN SIBERIA? NO, IT ISN'T". HE LAUGHS. JAN 7. I LEAVE MOSCOW BY TRAIN TO KIRISH, BELARUSIA, MY HOTEL BILL WINS 2200, RUBLES AND LETS TRAIN TICKET TO MINSK 150, RUBLES SO I HAVE A LOT OF MONEY HERE.
I WROTE MY BROTHER & MOTHER LETTERS IN WHICH I SAID I DO NOT WISH TO EVER CONTACT YOU AGAIN! I AM BEGINNING A NEW LIFE AND I DON'T WANT ANY PART OF THE OLD!
