**AGREEMENT**

I hereby acknowledge the filing of my application with JOBCO to assist me in securing a position and agree that providing I accept a position through JOBCO either directly or indirectly any time within one (1) year from the execution of this contract, to pay JOBCO an amount equal to forty per cent (40%) of the first month's salary, draw, commissions, or gross earnings, whichever sum is larger.
