Exhaustive efforts are being made to identify the latent fingerprints and palm prints found on four cardboard cartons (Exhibit C40) near the sixth floor window of the Texas School Book Depository (TSBD) immediately after the assassination of President KENNEDY. In addition to one latent fingerprint and one latent palm print which were identified as those of LEE HARVEY OSWALD, there were 19 additional identifiable fingerprints and six additional identifiable palm prints. Investigation to date has identified all of the latent fingerprints. There remains to be identified one latent palm print.

The Bureau has instructed that palm prints be taken of all FBI employees who were assigned to Dallas on special assignment at the time the Dallas Office came into possession of the four cardboard cartons, which was 11/26/63.

Therefore, each office receiving copies of this airtel is requested to immediately obtain the palm prints of the employees listed below which are assigned to their division, and submit same to the Latent Fingerprint Section of the Identification Division:
