It is further requested this letter be examined for latent fingerprints and that any such latents found be compared with the known fingerprints of OSWALD and with the fingerprints of MARINA NIKOLAEVNA PRUSAKOVA OSWALD, Alien No. 12530645, who was born 7/17/41, Severodvinsk, Russia, who is the wife of OSWALD.

Another set of fingerprints if needed will be obtained from MARINA OSWALD at a future date in the interviews with her.

For the information of the Bureau, the English translation of the enclosed letter prepared by SA ANATOLE A. BOGUSLAV at Dallas is as follows:

1. This is the key to the mail box which is located in the main post office in the city on Ervay Street. This is the same street where the drug store, in which you always waited is located. You will find the mail box in the post office which is located 4 blocks from the drug store on that street. I paid for the box last month so don't worry about it.
2. Send the information as to what has happened to me to the Embassy and include newspaper clippings (should there be anything about me in the newspapers). I believe that the Embassy will come quickly to your assistance on learning everything.
3. I paid the house rent on the 2nd so don't worry about it.
4. Recently I also paid for water and gas.
5. The money from work will possibly be coming. The money will be sent to our post office box. Go to the bank and cash the check.
6. You can either throw out or give my clothing etc. away. Do not keep these. However, I prefer that you hold on to my personal papers (military, civil etc.).
7. Certain of my documents are in the small blue valise.
8. The address book can be found on my table in the study should you need same.

9. We have friends here. The Red Cross also will help you. (Red Cross in English)

For information of Bureau, Mr. DOWD advised that sometime around the latter part of June, 1964, "Life" editor, JAMES THOMPSON, accompanied by another "Life" representative, visited Washington, D. C. and during their visit contacted GERALD FORD of the President's Commission and had dinner with Mr. FORD. DOWD explained that several weeks previous, Mr. FORD had made a social visit to "Life" office in NYC and on that occasion, Mr. THOMPSON was unavailable so THOMPSON later returned the visit as reflected above. DOWD stated that while THOMPSON was in contact with FORD, he, FORD, commented to THOMPSON that he is preparing a book regarding OSWALD and the assassination which he is not going to release, however, until after the public release of the report by the President's Commission.

DOWD remarked that FORD made a very general statement to Mr. THOMPSON regarding the probable length and size of the Commission's report but at no time did FORD or any other member of the Commission furnish any information re the OSWALD diary or any other information of a confidential nature and pertaining to the investigation by the President's Commission.

Being forwarded to the FBI Laboratory under separate cover, registered mail, are 12 photographs of OSWALD's diary; one photograph copy of a Communist Party letter dated July 31, 1963, addressed to OSWALD; one photograph copy of an undesirable discharge of OSWALD; one photograph copy of a vaccination certificate of OSWALD and two copies of a 35 millimeter film containing negatives of material seized by the Dallas Police Department at various locations belonging to LEE HARVEY OSWALD.

On July 9, 1964, HENRY WADE, District Attorney, Dallas, was interviewed concerning the "leak" of the diary, at which time WADE was most cooperative and advised that he would make the material available that his office had concerning the films and hard photograph copies obtained at the Recordak Company, Dallas, Texas. WADE was of the opinion that if the material was used from his office by any newspaper person, there may be some fingerprints on the material or on the two rolls of 35 millimeter film.

On July 10, 1964, WADE furnished the above material mentioned as enclosures to this letter, stating that he, WADE, WILLIAM F. ALEXANDER and H. H. DAVIS, JR. of his office could have possibly handled this material and that their fingerprints may be on the same. WADE requested that the material be returned to his office as soon as the FBI completes its examination.

For information of the FBI Laboratory, in making the fingerprint examination, SA's ROBERT M. BARRETT and IVAN D. LEE obtained the material from WADE without placing their latent prints on the paper or film. In obtaining fingerprint cards, it is noted that HENRY WADE is a former FBI Agent, WILLIAM F. ALEXANDER was a Lieutenant, U. S. Army, and that H. H. "SNOOKY" DAVIS, JR. served in the U. S. Navy as a pilot.

In the event any unknown latent prints are obtained from the film, Bureau requested to notify the Dallas Office, and background information will be obtained on the pertinent "Dallas Morning News" employees so the appropriate checks may be made against their fingerprints with the unknown latent prints.

The Photographic Laboratory is requested, upon receipt of the material from "Life" Magazine, to ascertain if that material was reproduced from the enclosed 35 millimeter Recordak film or possibly photographed from the hard copies of the diary which are being forwarded to the Laboratory. Bureau requested to conduct the investigation expeditiously in order that the material may be returned to HENRY WADE, District Attorney's office, Dallas, Texas.

One copy of this letter is furnished to the New York Office for information in view of the fact that office was requested to contact "Life" Magazine and obtain their copy of the diary as allegedly obtained from HUGH AYNESWORTH of "The Dallas Morning News."

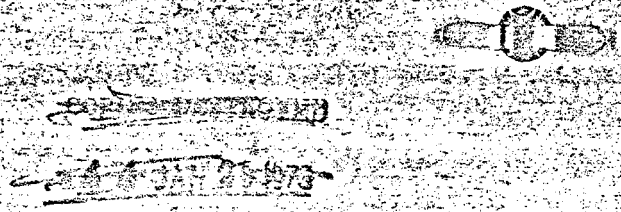
